- SANCTION: Held under USA/Pacific Swimming Sanction No.: **0547**
- LOCATION: Lombardi Pool; University of Nevada; Reno, NV. From I-80 take Virginia Exit. Go North on Virginia to The Lawlor Event Center. Turn right at Lawlor and go to stop sign. Lombardi is the big red brick building on the hill in front of you. **DO NOT PARK WHERE “NO PARKING SIGNS” ARE POSTED. YOU WILL RECEIVE A TICKET.**
- COURSE: Indoor heated 25 yard pool with 8 lanes. Electronic timing. Warm-up and warm down facilities will be available throughout the meet.
- TIME: SATURDAY: **GROUP A** warm-ups 7:30-8:15am, meet begins at 8:30 am
GROUP B Meet will not start before 12:00pm; and warm-ups will not start before 11:00am.
- SUNDAY: **GROUP A** warm-ups 7:30-8:15 am, meet begins at 8:30 am
GROUP B Meet will not start before 12:00pm; and warm-ups will not start before 11:00am.
- GROUP A includes 10 & UN girls and boys**
GROUP B includes 11 & UP girls and boys
- RULES: Current *USA Swimming* (USA-S) and Pacific Swimming rules will govern the meet. Pacific Swimming warm-up procedures will be in effect. A copy of these procedures will be posted at the Clerk of Course. All events are timed finals. All swimmers age 12 and under should complete competition within four (4) hours. Swimmers may enter as many events as they would like, but may only compete in five events per day. All coaches and deck officials must wear their USA-S cards in a visible manner. If local conditions warrant it the Meet Referee, with the concurrence of the Meet Director may require a mandatory scratch down to 4 or 3 events per swimmer. Immediate refunds will be made for any mandatory scratches. **“ENTRIES WILL BE LIMITED TO THE FIRST 150 SWIMMERS IN “GROUP A” AND THE FIRST 250 SWIMMERS IN “GROUP B” EACH DAY or when the meet estimated time line exceeds the "Four Hour Rule" per age group and gender.**
- RESTRICTIONS: Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating or standing areas and in all areas used by swimmers, during the meet and during warm-up periods. Sale and use of alcoholic beverages is prohibited in all area of the meet venue.
- ELEGIBILITY: All swimmers must have a current USA-S Registration Card and must enter the number on their entry cards. Swimmers who enter as “pending” or “applied for” must be prepared to present their current card or register before being allowed to check in unless the Meet Director determines that they are validly pending. Swimmers registering at the meet must pay a \$10.00 surcharge in addition to the regular fee. Meet is open to qualified members of invited USA-S teams. Disabled swimmers are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding special accommodations on entry times and seeding per Pacific Swimming policy. *Entry times submitted for this meet will be checked against a computer database and may be changed in accordance with Pacific Swimming Entry Time Verification Procedures.*
- CHECK-IN: The meet will be deck seeded. Swimmers must check in at the Clerk of Course. Close of check-in for all events shall be no more than 30 minutes before the estimated time of the start of the first heat of the event. Swimmers who do not check-in will not be allowed to compete in the event.
- SCRATCHES: Any swimmer who has checked in for an individual event and fails to swim that event will be barred from competing in the next individual event in which the swimmer is entered in this meet. The penalty will not apply if the swimmer scratches before the event is seeded or if the Referee accepts proof that the failure was caused by illness, injury or other circumstances beyond the control of the swimmer.

ENTRIES: **TWO OPTIONS FOR MEET ENTRY**

Option 1: **Online Meet Entries**

Enter at <http://swimconnection.com/pc/meet/reno> to receive immediate confirmation of acceptance via email. The “billing information” email should be brought to the meet as proof of entry. Online entry requires payment by credit card using our secure site. The cost of using Online Meet Entries is \$1 per swimmer plus 5% of the total entry fees. Please note that the processing fee is separate fee from the entry fees. Online meet entry fees are paid to Swim Connection LLC. Fees collected by the use of this system are completely voluntary. Online meet entry is no way required or expected of a swimmer by Pacific Swimming. Online Entries will close at Midnight on the 7th of March or earlier if the timeline exceeds the swimmer limit of: (150 per Session A or 250 per Session B) .

Option 2: **Traditional Postal System Mailed Entries:**

1. Fill out the provided Consolidated Entry Form completely for each swimmer in your family
2. Cut out your entry card(s) and mail to address below.

Each entry must be completely filled out including best short course time for each event. Entered times must be submitted in yards. “No time” entries will be accepted. Deck entries will not be allowed. A collect call may be made to verify incomplete or illegible information on any entries submitted. **Entries must be mailed with a postmark by Midnight, Monday, March 5, 2007 or hand delivered by 7pm Wednesday, March 7, 2007 to 3451 Cheechako Drive , Reno NV 89519. No late entries will be accepted. No refunds will be made. If you mail entries and need confirmation of entry, include a self-addressed stamped postcard/envelope. No phone calls please. Check <http://swimconnection.com/pc/meet/reno> for session open or closed status.**

ENTRY FEES: **\$2.25** per event. \$5.00 per swimmer participation fee to help cover meet expenses.

AWARDS: Blue Flight: Overlay ribbons 1st – 8th
Orange Flight: Ribbons 1st – 8th

*11-UP events will be awarded 11-12, 13-14, 15-18

*8-UN events will be awarded 8-UN and 9-10 will be awarded 9-10

If individual event has 24 entries or more checked in, the event will be divided into two flights. The faster half designated as the Blue Flight and the other as the Orange Flight. Identical entry times on each side of the division will be included in the Blue Flight as will the middle entry in an event with an odd number of swimmers. Events of less than 24 swimmers will have only a Blue Flight.

DISTANCE EVENTS: At the discretion of the Meet Director and Referee, dependent on the time line, the 500 yard freestyle may be limited to the fastest 24 male and 24 female swimmers checked in. In which case, those failing to make the cutoff will receive an immediate refund. It will be swum fastest to slowest, not alternating.

SNACK BAR: A small, limited snack bar will be available.

HOSPITALITY: Snacks and lunches will be served to all working officials and coaches.

ADMISSION: Free. Program available for \$5.00

PLEASE BE ADVISED THAT DUE TO UNIVERSITY RULES, PARENTS WILL NOT BE ALLOWED ON DECK.

Please note that the fire marshal will not allow any 11-up swimmers on the pool deck until the morning session is complete! We must also keep hallways clear at all times.

AMENDMENT

USA / Pacific Swimming Sanction Number: 0547
Reno Aquatic Club short course Invitational meet
March 17-18, 2007

Meet information sheet is amended to allow Deck Entries. Swimmers already entered in the meet may enter additional events to a total of no more than five (5) events per day. New swimmers (Walk-ons), with a valid Y2007 USA-S membership card in hand (NO EXCEPTIONS !), may enter up to five (5) events on the day of the event(s), at the Clerk of Course. Entry times submitted at the Clerk of Course will be checked post competition, against the Pacific Swimming computer database. Falsified seed times may be reported to the Pacific Swimming Board of Review.

If at any point acceptance of Deck Entries causes the meet's time line to exceed the limit of Four Hours of competition, for a swimmer of either gender, age 12 and under, Deck Entries will be CLOSED!

All other verbiage and rules remain as stated in the original sanctioned meet sheet.
