Less problems of paperwork changes for the PacSwim Office. Increase would allow for setting aside a reserve and still be able to fund PacSwim programs. The five year period is proposed considering the fact that the Pacific Swimming OME will be up and running within 5 years.</li> <li>Proposal of increasing the meet entry fees in view of the rising cost of renting pools and hosting meets. PacSwim does not want to have to subsidize meets. PC meets all looked at and would have a flat fee. Age group meets have a choice of a flat fee or use the percentage rated for number of meet days.
