**Announcements and Correspondence:**

- Sacramento has submitted a bid for the 2008 Olympic Trials. Clint has the brochure. The only other bidder to date is San Antonio.
- Anneliese is recuperating from pneumonia; she and Walt are not here tonight.
- The 2006 Western Zone Meet will not be held in Alaska as originally awarded. The only other bid was Central California, so will be a likely replacement.
- Joyce and Marvin reported on the meeting they attended last weekend in Colorado Springs.
- Joe Woo has been named to the National Officials Committee.
- Mike Metcalf has been named to the National Safety Committee.
- Clint Benton has been assigned to the Task Force for the House of Delegates.

**Financial Report:**

- The Preliminary End of Year report shows the net worth of Pacific Swimming, adjusted for the liability to USA Swimming and the commitment to the Salinas Pool Foundation, at \$1,008,026. Return on some investments has yielded 12.1%. Total Income exceeded the 2004 Budget by \$120,000, while Total Expenses were less than budget by \$17,000. The Age Group and Camp programs were under budget, while the Senior program exceeded budget.
- The report for the new year shows activity for Registration, Membership, the Quad Meet, Swim Guide and meet entry fees.
- Meet fees are past due from SBA for the A+ Meet held November 13-14 (fees were due on Dec 14); the club has been contacted and is in the process of submitting fees.

**Expenditure Authorizations:** (none)

**Motions and Resolutions – Action on Pending Motions and Motions Held Over**

M/S/ (D. Dillingham, G. Cleveland) Effective February 1, 2005, athlete members must be registered with Pacific Swimming and USA Swimming prior to entering any sanctioned competition. Registration forms and fees must be in the hands of the Pacific Swimming Registration Chairperson and be approved. Meet entries received from unregistered athletes will not be accepted into the meet. *Following discussion, the motion was ruled out of order. USA-S 302.1 "No swimmer alleged to be ineligible shall be denied the right to register and compete without being afforded the opportunity to refute the allegations relating to his/her possible ineligibility." National Times Verification Handbook, First Principle: "No unreasonable restriction must be placed on the right of the athlete to compete. His opportunity to compete must not be curbed by blind adherence to the rules and regulations for its own sake or merely because it makes it convenient for the adult volunteer."*

**Motions and Resolutions – New Motions:**

- M/S/ (H. Race, J. Woo) That Outreach athletes shall be charged 25% of the set co-pay to participate on all-star teams and at multi-day camps; co-pay for one-day camps shall not be reduced. *30-Day Motion held over to the February Meeting.*
- M/S/C (D. Takaki, S. Shea) That 2004 Pacific Swimming 'A' times be set as the qualifying time standards for the 2005 10/under Championships (to be hosted on April 30 by MBSC).
- M/S/ (D. Power, J. Lanphere) That Pacific Swimming establish a written baseline format for the 10/under Championship Meet prior to bid for 2005. *Referred to the Age Group Committee as an Action Item; resolution is required prior to solicitation of bids, and must be brought to the Board by May.*
- M/S/ (G. Ng, L. Rice) Timing System requirements in Pacific Swimming. Amend the Pacific Swimming Rules and Regulations, Section 3. Conduct of Meets, A. Rules, to add new item 8, as follows:

8. Timing systems to be provided by meet hosts of all sanctioned meets in Pacific Swimming shall meet the following USA Swimming Timing System Levels:

A. Level 1 - Primary system: Automatic

Level 1 timing may be used at any meet. A backup system with a minimum of two buttons and a tertiary system of at least one manual watch shall also be provided;

B. Level 2 - Primary system: Semi-automatic with 3 buttons

Age group meets with qualifying times of A or higher (including multi-class meets) and Junior and/or Senior meets must have at least a Level 2 primary timing system with a minimum backup system of at least one watch;

C. Level 3 - Primary system: Semi-automatic with 2 buttons or Manual with 3 watches

All other sanctioned meets in Pacific Swimming must have at least a Level 3 primary timing system. If such system consists of semi-automatic timing with two buttons, a backup system of at least one watch shall be provided.

D. Level 4 - Primary system: Manual with 2 watches

Level 4 timing may be used only to achieve Pacific Swimming age group time standards below A.

This change will be effective 1/1/2006, but it is strongly recommended that it be implemented as soon as possible by all meet hosts. *30-Day Motion held over to the February Meeting.*

- M/S/T (J. Woo, J. Lanphere) Amend the Policies & Procedures, XVI Awards and Banquet, 6.0 (formula for charging attendees). *Tabled until we have more information; need cost actually charged by the hotel for the 2004 Banquet, number of attendees by category and the amounts they paid.*
- M/S/ (J. Woo, E. Totah) Amend the Policies & Procedures, XVI Awards and Banquet, scoring of age group swimmers, to add one point for each NRT achieved regardless of ranking. *30-Day Motion held over to the February Meeting.*
- M/S/F (G. Hinderliter, F. Siegrist) That the complete monthly Financial Report shall be posted on the website as part of the Newsletter. *The financial report is always available to any member by contacting the Treasurer.*
- M/S/C (R. Waterhouse, G. Cleveland) That the determined airfare for the World Championship Trials in Indianapolis (April 1-6, 2005) be set at \$325.

**Regular Reports:**

**Membership/Non-athlete** (Laurie Benton) – To date, 296 coaches and 649 other non-athletes have applied for membership in 2005, for a total of 945 memberships. There are 90 clubs (no organizations).

**Registration/Athletes** (Judy Siegrist) –

- Regular athlete registrations to date are 10,438, and fall season registrations are 1,735, for a total of 12,173. This significantly exceeds 2004 at the same time of 10,767.
- USA-S now has the option of electronic registration by team. WCAB tried it as a test – it worked well. Teams interested in this option for the future should contact the Siegrists.

**Zone 1N** (Ugur Taner) – Met this week. Zone Champs will be held this weekend (Jan 29-30). Next meeting in March.

**Zone 1S** (Darwin Takaki) – Met Jan 12. Held Zone champs on Jan 15-16, with 1470 swimmers and 7700+ splashes. Identified a need for more marshals; will discuss a plan similar to the one used to increase S&T judges. Next meeting on Mar 9.

**Zone 2** (Gwenn Chong) – Met January 24. Established a Scheduling Committee and a Nominating Committee. Zone Champs will be held Feb 12-13.

**Zone 3** (Chris Wells) – Met January 10. Established a Nominating Committee and a committee to look at time standards for summer long course championship. Held Zone Champs on Jan 15-16, with 600+ swimmers. Next meeting will be March 21.

**Zone 4** – No report.

**Senior** (Scott Shea) – Established a committee to discuss future senior projects in the LSC; members are Sage Hopkins (DACA), Danny Graves (SRN), Brian Bolster (OAQ), Ray Mitchell (TERA), and Scott Shea. Will be reviewing the Senior Champs held in December.

**Age Group** (Joe Woo) – Met this evening.

- Have two new committee members – Ricky Silva, Coach Rep, and Chris Oshiro, Zone 3 Rep.
- The Quad Meet was held last weekend; Pacific placed 2<sup>nd</sup>. Traveling the night before (instead of the morning of the first day of the meet) gave the swimmers more rest, which was beneficial. The results of the meet have many errors and are being revised. The new selection process (having a time period in which to qualify rather than performance at a single meet) was good.
- The Committee is currently preparing for Western Zone at Salt Lake City.

**Coaches** – No report.

**Athletes** – no report.

**Additional Reports:**

**Newsletter/Website** (Rick Beebe) –

- The Pacific Swimming website received an average of 100,000+ page requests per month in 2004; this was a 50% increase over 2003. The months of the Far Western meets are the biggest, and Monday is generally the day of the week with the most volume. We are planning some website revision.
- The Newsletter will be published in electronic format beginning next month. It will be posted on the website; Board members and Clubs will receive an email with a link to the posting. The email will not include an attachment, due to size limitations of some email addresses and virus issues. The Newsletter will no longer include the Top 5 and Top 10 as that information is already posted on the website.

**Travel** (Rick Waterhouse) – Recommendation of travel assistance for the World Championship Trials to be held in Indianapolis, April 1-6 (see motion above).

**Nominating Committee** (Gerry Ng) – The Committee met this evening; Gerry was selected as Chair. Will be publishing a candidate form for nominations.

**Officials Committee** (Gerry Ng) –

- Clinic held in January had approx 50 attendees.
- Zone Officials Chairs should send info to Millie Nygren about zone clinics. We need to track who has attended and who has completed the “exam”.
- Appointment of Zone 4 Officials Co-Chair Steve Braun has not been confirmed by Pacific.

**Time Standards** (Owen Melroy) – A suggestion has been made from Zone 3 that Pacific consider adoption of the USA-S ‘BB’ time standards. This is an intermediate step between the ‘B’ and ‘A’ time standards. Considering the significant gap now existing between ‘A’ and ‘B’ times, request that the Age Group Committee take this matter under review and report back to the Board.

**New Business** -

- Swim Guides for 2005 are now available. Clubs may contact Gary Hinderliter for additional copies.
- Swim Connection is an official database for SN times, but **not** for PC times.

- Saturday, 29 January, Stanford Women's Swimming will host the USC Women. All non-high school swimmers (of less than high school age) are invited to attend – FREE

**Announcements and Correspondence:**

- The FBI has requested the assistance of the swimming community in locating a fugitive; Lorrie John Trites is a former swim coach in Lancaster, PA. He may have fled the country and is likely using another name. The FBI wanted poster may be viewed at <http://www.fbi.gov/mostwant/fugitive/feb2005/febtrites.htm>; additional information is available at <http://www.swiminfo.com/lane9/news/8907.asp>. Anyone with information on this person is asked to contact a local FBI office or an American Consulate or Embassy.
- Tom Peirona, a Zone 1N official, has passed away.
- HyTek wishes to notify the swim community that their program is in compliance with the USA-S policy on privacy.
- A tsunami relief clinic will be held on April 9 at Stanford. Information will be posted on the PacSwim website.
- Sacramento was eliminated as a contender for the 2008 Olympic Trials. The primary issue was the expected temperatures in this outdoor venue; a secondary consideration was that Beijing will hold competition in an indoor facility.
- The PC General Chair and Officials Chair request that each Zone provide a written basis for any fine or penalty assessed against teams relating to requirements for officials, or any other requirements or standards set for officials at the Zone level.
- A new safety reminder has been issued regarding lightning strikes and pool safety. See <http://www.pacswim.org/whatsnew.htm>.
- The General Chair has received several complaints regarding the new time standards. A survey was sent to 270 coaches - there were 89 replies; 67 favored a return to the previous time standards and 22 feel the new standards should be kept.
- Gerry Ng is working at the Pac-10 Women's Champs in Federal Way, WA. His absence is Excused.
- 17 members of Pacific Swimming have been named to USA-S committees. [List provided at the end of the Minutes]
- The date of the North Coast Zone 3 Camp has been changed from March 26 to April 9, 2005. The location will be the same: The College of the Redwoods, Eureka.
- Hale Adams (Colorado) has passed away. He was well known within the Western Zone. He will be replaced on the USA-S Governance Task Force by Larry Johnson (Montana).

**Presentation by MSJA**

- MSJA has plans to build a new indoor swimming facility in the City of Fremont. It will include two pools (one will be 50m x 25yd, and one 25yd x 30yd), locker rooms, a pro shop, café, weight room and multi-purpose room.

- The facility will be privately owned by MSJA. They have been approved for a \$9 million loan, and need \$2.4 million in donations. Completion is projected for Summer 2006.
- A Committee is appointed to review the project and report on the advisability of a donation from Pacific Swimming. Don Power (Chair), Mary Yoshida, Kent Yoshiwara, Scott Shea, Millie Nygren. Report is due next month.

**Financial Report:**

- For the first two months of the year, income has exceeded expenses by \$17,000.

**Expenditure Authorizations:**

- M/S/C (M. Yoshida, J. Dillingham) To authorize the expenditure of \$2,850 for the North Coast Zone 3 Camp, to be held in Eureka, CA on April 9, 2005. This will cover the cost of pool, classroom, hotel, food, clothing, speaker and misc expenses, and is the amount approved in the 2005 budget.
- M/S/C (M. Yoshida, M. Nygren) To authorize the expenditure of \$2,850 for the Adam Szmidt Memorial Camp for 10/Unders to be held in Sunnyvale, CA on May 1, 2005. This will cover the cost of pool, classroom, hotel, food, clothing, speaker and misc expenses, and is the amount approved in the 2005 budget.
- M/S/C (F. Siegrist, J. Lanphere) Approve the purchase of HyTek Team Manager at \$85/copy for 50 teams, a total of \$4,250. The budget planned \$7000 for 100 teams. This will provide reimbursement to teams that purchase and use electronic registration. For those teams that already have Team Manager but wish to upgrade to the current version (Version 4.0), the cost of the upgrade will be covered.
- M/S/C (F. Siegrist, J. Lanphere) To authorize an additional \$100/person for costs associated with the change of location (from Colorado Springs to Tampa, FL) for the USA-S Registration/Membership Seminar, April 14-17. Fred Siegrist, Judy Siegrist and Laurie Benton are attending.
- M/S/C (J. Woo, M. Nygren) To authorize \$500 for airfare for the Age Group Chair Workshop to be held at Colorado Springs, April 22-24. Other expenses are covered by USA-S.
- M/S/C (G. Hinderliter, R. Beebe) To approve a budget increase from \$2000 to \$5415, and the associated expenditure, for a makeover/upgrade of the Pacific Swimming web site. A fixed price proposal has been obtained from Relevant Tools of San Rafael.

- M/S/ (J. Woo, J. Lanphere) Amend the Policies & Procedures, XVI Awards and Banquet, 6.0 (formula for charging attendees). *Motion was tabled in January and brought back to the Board in February. Motion is to be reworded and re-presented in March, at which time it will be a 30-Day Motion for consideration in April.*

**Motions and Resolutions – New Motions:**

- M/S/C (M. Nygren, M. Yoshida) That time standards for the Stanford University Invitational Grand Prix meet, to be held May 20-22, 2005, be set equal to the Speedo Challenge (LCM) time standards.
- M/S/ (J. Koch, M. Nygren) Change the scoring formula for the FWSC meet to eliminate the scoring for the 15-18 age group, to be effective in 2006. *60-Day Motion for consideration in April; referred to the Age Group Committee for recommendation.*
- M/S/C (J. Dillingham, J. Lanphere) That records for the new 15-18 age group relays be established at the fastest time submitted by August 31, 2005, provided that it meets the NRT time standard.

**Regular Reports:**

**Membership/Non-athlete** (Laurie Benton) –

- To date, 330 coaches and 731 other non-athletes have applied for membership in 2005, for a total of 1,061 memberships. There are 95 clubs and 1 organization.

**Zone 1N** (Scott Shea) – At the last meeting, a vote was taken which showed support for a return to the old time standards. This is a recommendation only to Pacific as no action can be taken. Next meeting will be March 7.

**Zone 1S** (Darwin Takaki) – Nothing to report. Next meeting will be March 9.

**Zone 2** (Kim Jew) – Next meeting will be February 28.

**Zone 3** (Chris Wells) – No meeting was held in February. Next meeting will be March 21.

**Zone 4** – No report.

**Senior** (Scott Shea) – Nothing to report yet from the committee to discuss future senior projects in the LSC.

**Age Group** (Joe Woo) – Met this evening and discussed the need to establish a written baseline for bidding on Pacific meets. A report is due by May.

**Disability Swimming** (Walt Eggert) –

- The USA-S Committee formerly called Adapted Swimming has been renamed to Disability Swimming., and has a new Chair from the Pacific Northwest LSC, Kiko Van Zandt.
- The proposal to hold a Jr meet in conjunction with the next Disability Championships has been dropped for lack of planning time.

**Finance and Audit** (Joyce Lanphere) – A statistical report was presented for the fiscal year 2004.

**Records** (Jacquie Dillingham) – USA-S has reactivated the category of 15-18 for relays. [see Motion above.] Pacific will continue to recognize 15-16 and 17-18 for records, if they occur.

**College** (Millie Nygren) – The Cal men beat the Stanford men! This was the first time in 25 years, and was the first time that Cal had competed in Diving.

**High School** (Elias Totah) –

- New rule books for 2005 are available; see Elias (email: [dukstop@sbcglobal.net](mailto:dukstop@sbcglobal.net) ) The Situations for review are now at the end of each section rather than at the end of the book.
- A major change for this year is in the individual medley; the transition between strokes will be judged as a finish rather than as a turn, which coincides with USA-S rules.
- ~~CIF has approved SoCal swimmers to remain attached to their USA-S clubs during the high school season. This was approved for SoCal ONLY—PC swimmers must swim UN (unattached), except for national and sectional meets.~~ **(Note: the above wording is incorrect. CIF has allowed SoCal swimmers to swim attached to their USA-S clubs for their JOs, but otherwise, like Pacific swimmers, they may swim attached to a USA-S club during high school season only in national and sectional championship meets.)**

**Announcements and Correspondence:**

- Korey Hayman is present, representing the Union City Leopard Sharks.
- The Coach's test is now available online through the USA-S website. It reports automatic notification back to PC.
- The USA-S annual convention will be held 13-18 Sep 2005 in Greensboro, NC. Anyone planning to attend should let Clint know, especially if you want an At Large vote. Travel information is being developed.

**Financial Report:**

- The Treasurer is absent; his printed report was distributed. The net worth of PC continues to improve; after adjustment for the liability to USA Swimming and the commitment to the Salinas Pool Foundation, it is \$1,047,472.

**Expenditure Authorizations:**

- M/S/C (G. Ng, G. Hinderliter) To authorize the expenditure of \$1,100 to send two people to the Officials Workshop in Colorado Springs, which is within the 2005 budget (56545 and 56550).

**Motions and Resolutions – Action on Pending Motions and Motions Held Over**

- M/S/C (A. Eggert, J. Lanphere) Amend the following motion (timing system requirements) to include in Level 1 "... may be used at any meet, and is required for all meets with J.O. qualifying time standards or higher."
- M/S/C (G. Ng, L. Rice) Timing System requirements in Pacific Swimming. Amend the Pacific Swimming Rules and Regulations, Section 3. Conduct of Meets, A. Rules, to add new item 8, as follows:

8. Timing systems to be provided by meet hosts of all sanctioned meets in Pacific Swimming shall meet the following USA Swimming Timing System Levels:

A. Level 1 - Primary system: Automatic

Level 1 timing may be used at any meet, and is required for all meets with J.O. qualifying time standards or higher. A backup system with a minimum of two buttons and a tertiary system of at least one manual watch shall also be provided;

B. Level 2 - Primary system: Semi-automatic with 3 buttons

Age group meets with qualifying times of A or higher (including multi-class meets) and Junior and/or Senior meets must have at least a Level 2 primary timing system with a minimum backup system of at least one watch;

C. Level 3 - Primary system: Semi-automatic with 2 buttons or Manual with 3 watches

All other sanctioned meets in Pacific Swimming must have at least a Level 3 primary timing system. If such system consists of semi-automatic timing with two buttons, a backup system of at least one watch shall be provided.

D. Level 4 - Primary system: Manual with 2 watches

Level 4 timing may be used only to achieve Pacific Swimming age group time standards below A.

This change will be effective 1/1/2006, but it is strongly recommended that it be implemented as soon as possible by all meet hosts.

- M/S/ (J. Woo, J. Lanphere) Amend the Policies & Procedures, XVI Awards and Banquet, 6.0 c. and d., as follows:
    - c. All other banquet attendees will be charged \$10.
    - d. Children 6 and under accompanying an adult attendee will not be charged for the meal.
- 30-Day Motion for consideration at the April meeting.*

**Motions and Resolutions – New Motions:**

- M/S/ (D. Takaki, G. Cleveland) To amend line item 58000 in the Pacific Swimming budget for 2006, allocating \$33,000 to the Zones in support of Pacific Swimming's Zone All-Star Developmental Meet. \$6000 is to be allotted to each Zone, and an additional \$3000 to the host Zone for pool, timing equipment, awards and other miscellaneous items. All disbursements must be substantiated with receipts. *60-Day Motion for consideration at the May meeting.*
- M/S/ (D. Takaki, T. Krohn) Pacific Swimming shall adopt the USA-S "BB" time standards, to be added to the current Pacific Swimming time standards, effective immediately. *60-Day Motion for consideration in May.*
- M/S/F (M. Nygren, H. Race) That Stanford [PASA] be allowed a reduction of fees to be paid to Pacific Swimming, from \$1.50 to \$.75 per entry, for the Grand Prix meet scheduled for May 2005. This fee reduction would also be permitted for the Santa Clara International meet.
- M/S/F (M. Nygren, G. Hinderliter) That Stanford [PASA] be allowed to charge no entry fee for time trials at the Grand Prix meet in May 2005. Stanford [PASA] will pay the sanction fee for time trials. This arrangement would also be extended to Santa Clara.
- M/S/C (J. Geary, G. Cleveland) That the standard language indicating that a \$10 surcharge will be due to Pacific for on-deck registration be deleted from the meet sheet for National or Grand Prix meets in which USA-S verifies registration.
- M/S/C (W. Eggert, G. Ng) That the budget planned for travel assistance to the National Disability Meet be extended for travel to the Paralympic Meet in Ht. Hood, Oregon, this year only.

**Regular Reports:**

**Membership/Non-athlete** (written report) – To date, 351 coaches and 770 other non-athletes have applied for membership in 2005, for a total of 1,121 memberships. There are 100 clubs and 1 organization.

**Registration/Athletes** (written report) – Regular athlete registrations to date are 11,411. This is up 12% over the same time last year.

**Zone 1N** (Larry Rice) – Last meeting was March 14. Major discussion on time standards. Next meeting will be May 9.

**Zone 1S** (Darwin Takaki) – Last met on March 9. Discussed the potential change in scoring at Far Westerns next year, and selected a nominating committee. Next meeting will be May 11.

**Zone 2** (Gwenn Chong) – Last met on March 22. Discussed the All Star meet, zone champs meet. Next meeting will be May 24.

**Zone 3** (Chris Wells) – Last met on March 21. Had meet reports for meets held in January thru March 20. Discussed the All Star Meet and time standards for the closed zone championship meet. Next meeting will be April 23.

**Zone 4** (Randy Burns by written report) –

- Last Fall, the zone voted for two co-chairs for Officials. The zone was not notified until after the Swim Guide had been published that Pacific had not approved one of the co-chairs. The zone does not understand why Pacific has jurisdiction over their officers. [Response: The Pacific Swimming Rules & Regulations (Section 8 – Officiating, B. 5.) provides for approval of the Zone Officials Chair; this is the only zone officer subject to such approval. The

General Chair and the Officials Chair of Pacific Swimming were not made aware of Zone 4's Officials Co-Chairs prior to issue of the Swim Guide.]

- Zone 4 discussed the motion (above) regarding expanded budget for the All-Star Developmental Meet, and favors this motion.
- Gerry Ng advised Zone 4 of the forthcoming National Officials Workshop; the zone recommended Van Fortier as a candidate to attend. Van is an understudy for the position of Zone Officials Chair. [It was reported elsewhere that Van will be an attendee.]

**Senior** (Jerry Koch) – Submitted this evening, a proposed schedule of meets for 2006 to the Scheduling Committee. The Senior Chair needs to be involved in this process; senior meets must be scheduled so that our swimmers are prepared to enter Grand Prix meets and others of a similar caliber.

**Age Group** (Joe Woo) – The committee has discussed the criteria for various age group meets. A draft will be available for review at the Far Western meet, with a final report to be presented to the Board in April.

**Coaches** (Todd Krohn) – A coach has asked “Why is a printout from Swim Connection not acceptable for requirements of “provable times” at Pacific meets? [Swim Connection is not the database of record for Pacific, as it is for Sierra Nevada and a few other LSCs. Also, if meet results have been correctly reported, a swimmer's times are available through the USA-S database. No password is required to access this information.]

**Athletes** – No report.

#### **Additional Reports:**

**Disability Swimming** (Walt Eggert) –

- Disability Championships will not be hosted by USA-S this year; the proposed Jr. meet will also not be held.
- There will be a Paralympic Meet held in Mt. Hood, Oregon. (see motion above regarding travel assistance)

**National Legislation** (Anneliese Eggert) – The committee to revise Governance has made the following recommendations:

- That the number of members of “Large” Committees be cut back.
- That the OIOC remain a Large Committee.
- That the President appoint 5% instead of 10% to be At-Large delegates.
- That members attending the House of Delegates for the first time should have “voice but not vote”.
- That items coming from the floor at the last minute in the House of Delegates must carry 90% of the vote to pass.

**Officials** (Gerry Ng) – Attendees at the National Officials Workshop in Colorado Springs will be Teri May (Zone 2) and Van Fortier (Zone 4).

**Nominations** (Gerry Ng) – The Committee is still accepting nominations for all offices. Interested candidates should complete the Candidacy Form, available on the PacSwim website (<http://www.pacswim.org/05nominations.pdf>), and may contact Anneliese Eggert ([aeggert@att.net](mailto:aeggert@att.net)) or George Cleveland ([george2cleveland@aol.com](mailto:george2cleveland@aol.com)). The Committee is seeking new people for various Board positions.

#### **New Business -**

- Update on Salinas Pool (George Cleveland) – Groundbreaking has been postponed, and is now planned for September or later. Representatives will be going to the Colorado Springs workshop next month.
- Ad Hoc Committee / MSJA Pool (Don Power) – Committee met briefly this evening. Will make a recommendation next month.
- Scheduling (Kim Jew) – The schedule will be proposed to the Board in April, to be voted on at the May meeting. Bid packages will go out in May and will be posted on the website, and will include the criteria to be proposed by the Age Group Committee. Bids will be due by 5:00 p.m., Monday 20 June. The Committee will meet Tuesday 21 June to make recommendations for meet assignment, which will be submitted to the June Board meeting.

**Presentation** – Mark Carter, Coach of the Flying Fish (Fremont)

- Regarding the new Pacific time standards, "A" times are no longer achievable for most "B" swimmers and, therefore, are no longer motivational. The proposed "BB" time standards, while providing an intermediate step between "A" and "B", would not provide the motivation previously available. He would like to see a return to the previous time standards or something similar.
- The Coaches group makes annual awards to the top Senior Coach and Age Group Coach. There are many coaches who do not fall into either of these categories; there is a need for recognition of Developmental Coach.

**Financial Report:**

- For the current month, Pacific had an excess of income over expenses of \$46,000. This compares to \$39,000. last month. The net worth, adjusted for our liability to USA-S and our commitment to the Salinas Community Pool Foundation, is \$1,054,191.

**Expenditure Authorizations:** None.

- M/S/C (N. Shaw, M. Yoshida) That the meeting normally scheduled for July 27, 2005, be rescheduled to July 20, 2005. Reason: July 27 is the first day of FWLC 2005.
- M/S/ (K. Jew, M. Yoshida) That the schedule proposed for 2006 be accepted and sent out to bid in May. *30-Day Motion for consideration in May.* (see attachment)
- M/S/ (J. Woo, L. Rice) That the proposed minimum criteria for Pacific Age Group Swim Meets be adopted. *30-Day Motion for consideration in May.* (see attachment)

  - iii. If a declared false start in finals is reported to the Referee prior to the start of an event final, the Meet Referee may allow the substitution of alternates in accordance with the procedures in USA Swimming rulebook sections 207.7.9 D (2), (3) and (4).  
The decision to use this procedure for a given meet must be stated in the Meet Information Sheet. *30-Day Motion for consideration in May*
- M/S/ (J. Woo, J. Lanphere) Modify the existing rule 5.b.(3) *Scratching from Consolation Finals and Finals*, to add the following sentence at the end of paragraph (i): Swimmers who missed the scratch deadline but do not wish to compete MUST show up at finals when the heat is called by sitting on the block to signify their intention to withdraw from finals. *30-Day Motion for consideration in May*
- M/S/ (J. Woo, J. Lanphere) Modify the current rules 5.b.(4) and (5), as follows:

5.b.(4) Penalty for ~~Failure to Compete~~ *No-Show at Finals*

(i) Any swimmer qualifying for a consolation final or final race in an individual event who fails to ~~compete~~ show up in said consolation final or final race prior to the deck referee turning over the heat to the starter shall be barred from further competition for the remainder of the meet.

(ii) If the ~~failure to compete~~ “No-Show” occurs on the last day that the swimmer is entered in an individual event in the meet, and no other penalty is applicable, the swimmer shall then be fined \$25.00.

5.b.(5) Exceptions for ~~Failure to Compete~~ – No penalty shall apply for failure to withdraw or compete in an individual event if:

(i) The referee is notified in the event of illness or injury and accepts the proof thereof.

(ii) It is determined by the referee that the ~~failure to compete~~ “No Show” is caused by circumstances beyond the control of the swimmer.

(iii) The swimmer qualified for any level of finals due to scratches of one or more original finalists.

(iv) The swimmer is an alternate for any level of finals.

- M/S/C (G. Cleveland, M. Yoshida) SVAA requests approval of fees for the 2005 Age Group International Meet, as used previously for the same meet. (\$5.50/individual event, \$5.00 participation fee, \$16.00/relay)
- M/S/C (G. Cleveland, M. Yoshida) Accept the recommendation of the Chair to appoint Carole Yoshiwara as Athlete Representative to the PacSwim Board.

M/S/ (D. Power, G. Cleveland) That Pacific Swimming pledge to make a donation of \$250,000 to (Legal Name of MSJA Pool Foundation) to assist in the construction of a new, indoor, 50-meter pool complex; and

- M/S/C (R. Waterhouse, M. Yoshida) That the determined airfare for 2005 USA Swimming Senior Nationals at Irvine, Aug 3-7, shall be \$250.
- M/S/ (G. Cleveland, O. Melroy) For the year 2005 only, swimmers competing in the USA Swimming Junior National Championships in Irvine, California shall be eligible for travel assistance as provided in Pacific Swimming Rules and Regulations Section 9 on the same basis as for the U.S. Open. *30-Day Motion for consideration in May.*
- M/S/ (G. Cleveland, M. Yoshida) The determined airfare for the 2005 USA Swimming Junior National Championships in Irvine, California shall be \$250. *30-Day Motion for consideration in May.*

#### **Regular Reports:**

**Membership/Non-athlete** (Laurie Benton) – To date, 367 coaches and 805 other non-athletes have applied for membership in 2005, for a total of 1,172 memberships. There are 102 clubs and 2 organizations.

**Registration/Athletes** (Judy Siegrist) – Regular athlete registrations to date are 11,737. Summer season registrations are 149. Total registration is 11,886, a 9.9% increase over 2004 at this time (10,814).

**Zone 1N** (Larry Rice) – Last meeting was March 14. Established a nominations committee; elections will be in July. Next meeting will be May 9.

**Zone 1S** (Darwin Takaki) – Last met on March 9. Next meeting will be May 11.

**Zone 2** (Gwenn Chong) – Last met on March 22. Next meeting will be May 24.

**Zone 3** (Chris Wells) – Last met on April 18. Moved the Zone 3 Long Course Champs from July to June; the meet will be hosted by Vallejo in a timed finals C/B/A+ format and is a closed meet (Zone 3 swimmers only). Held a mini board meeting in Eureka on April 23. Had a good turnout of club members from the Crescent City Swim Club, Redwood Swim Club, Humboldt Swim Club, Mendocino Coast Sea Lions and Ukiah Dolphins. The majority of the clubs have problems getting enough time each week for swim practice; some clubs have as little as 7 hours/week and have to share the pool with lap swimmers. Next meeting will be May 18.

**Zone 4** – No report.

**Senior** – No report.

**Age Group** (Joe Woo) –

- The committee has discussed the criteria for consideration in bidding and award of meets. A matrix of the affected meets and the minimum criteria for each was presented this evening. (motion above)
- A recommendation was made that the Senior Committee develop similar requirements for senior meets.
- A new member of the Committee is present this evening, Lehla Irwin, representing the Zone 3 coaches.
- Joe attended the Age Group Workshop in Colorado Springs, April 22-24, 2005:

- In the coming budget, USA-S will eliminate the Camp program. Pacific is the only LSC that takes advantage of USA-S funding for camps. Lack of this support will have an impact in the PC Camp Budget for future years.
- USA-S is considering recognition of individual ages instead of age groups.
- Other LSCs tend to ignore the 4-hour rule, beyond putting the required language in meet sheets. Also, they have found an impact on meets accepting online entries.
- To the surprise of many Age Group Chairs, it was emphasized that motivational time standards are NOT meant to be used for swim meets.

**Coaches** (Todd Krohn) – At the recent Far Western short course meet, Tammy Hopkins was elected by her colleagues to represent the Jr Coaches to the PacSwim Board. She was asked to participate as a member of the Age Group Committee.

**Athletes** – Dash Rothberg has stepped down from this appointment. Clint recommends the appointment of Carole Yoshiwara. (see Motions, above)

#### **Additional Reports:**

##### **Ad Hoc Committee to Evaluate the MSJA Pool Proposal** (Don Power) –

- Following a detailed report of investigation, the Committee presented a Resolution (see Motions, above).

##### Clarifications:

- Pool construction is scheduled to commence in 3Q05.
- Pool construction is scheduled to complete in 3Q06.
- The award of the 2008-2011 PacSwim Senior Winter Champs shall be subject to satisfactory performance in the previous year as determined by the PacSwim Senior Vice Chair.
- For the purpose of this discussion, a “Camp” shall be defined as an activity sanctioned by Pacific Swimming that shall have duration of not more than 3 days and shall include not more than 64 athletes.
- MSJA shall have the right to bid any meets awarded by Pacific Swimming. Such bids shall be evaluated using the same criteria as other bidders.
- MSJA may choose to partner with other Pacific Swimming Club Members to bid such meets. The terms of that partnership are solely the responsibility of the participants.
- MSJA may bid other meets (such as Zone 2 Age Group meets, Western Zone Sectionals or USA-S Grand Prix Meets) under the guidelines set forth by the governing body.

**Announcements and Correspondence:**

- Convention packets are now available. See Clint if you did not receive one; materials are also available on the USA-S website. PC will reimburse members for the "Early Bird" registration fee of \$110. (see Policies & Procedures, p. 8-9)
- Pacific has ordered the 2006 registration forms; however, PC decided to absorb the USA-S increase in fees for 2006. The Budget Committee will need to review the impact on expected income, and decide whether a fee increase for 2007 should be recommended.

**Financial Report:**

- For the current month, Pacific had an excess of income over expenses of \$53,393 – an increase of \$8000 over last month. The net worth, adjusted for our liability to USA-S and our commitment to the Salinas Community Pool Foundation, is \$1,061,404.

**Expenditure Authorizations:**

- M/S/C (M. Yoshida, G. Cleveland) To authorize the expenditure of \$17,950 for the Junior Leadership Camp to be held on Aug 12-14, 2005, at Menlo Atherton High School. These funds will cover the cost of pool, classroom, hotel, food, ground transportation, clothing, speaker and miscellaneous expenses. This is the amount approved in the 2005 Budget.
- M/S/C (F. Siegrist, G. Cleveland) To advance the authorized amount of travel assistance for Convention, to Board members who have already purchased tickets. If travel is not completed, the amount must be repaid to PC.

**Motions and Resolutions – Action on Pending Motions and Motions Held Over:**

- M/S/F (J. Koch, M. Nygren) Change the scoring formula for the FWSC meet to eliminate the scoring for the 15-18 age group, to be effective in 2006. [The Age Group Committee recommends against this motion.]
- M/S/C (K. Jew, M. Yoshida) That the schedule proposed for 2006 be accepted and sent out to bid. (some corrections were made to holiday dates on the attachment)
- M/S/C (J. Woo, L. Rice) That the proposed minimum criteria for Pacific Age Group Swim Meets be adopted, effective January 1, 2006. [The requirement for complimentary hotel rooms was amended to be a recommendation.] (see attachment)
- M/S/W (A. Eggert, G. Cleveland) Add to Scratch Procedures (pg 72 in the Swim Guide), new section 5.b.(3) iii (renumber subsequent sections):

iii. If a declared false start in finals is reported to the Referee prior to the start of an event final, the Meet Referee may allow the substitution of alternates in accordance with the procedures in USA Swimming rulebook sections 207.7.9 D (2), (3) and (4).  
The decision to use this procedure for a given meet must be stated in the Meet Information Sheet.

*Motion is Withdrawn and the following motion is substituted:*

- M/S/T (A. Eggert, G. Cleveland) Modify Pacific Rules and Regulations, Section 3, 5.b.(3) Scratching from Consolation Finals and Finals, (Swim Guide p. 72) as follows:
  - (i) Swimmers qualifying for consolation finals or finals who do not wish to compete must scratch within 30 minutes after the announcement of qualifiers. During this period, qualifiers may also notify the referee that they may not intend to compete in consolation finals or finals. In this case they must declare their final intention within 30 minutes after the announcement of qualifiers following their last individual preliminary event.
  - (ii) (new) Swimmers may declare a false start in finals by reporting their intent to the referee when the first finals heat of their event is called to the blocks. Such declaration will be considered a withdrawal and alternates may be substituted in accordance with (iii) below.
  - (iii) *(renumbered from ii)* In the event of withdrawal or barring of a swimmer from competition, the referee shall fill the consolation final or final when possible with the next qualified swimmer(s). First and second alternates shall be announced along with the final qualifiers. These alternates shall not be penalized if they are unavailable to compete in the finals.  
*Renumber (iii) and (iv) as (iv) and (v), respectively.*

*Motion is Tabled.*

- M/S/T (J. Woo, J. Lanphere) Modify the existing rule 5.b.(3) *Scratching from Consolation Finals and Finals*, to add the following sentence at the end of paragraph (i): Swimmers who missed the scratch deadline but do not wish to compete MUST show up at finals when the heat is called by sitting on the block to signify their intention to withdraw from finals. *Motion is Tabled.*
- M/S/C (J. Woo, J. Lanphere) Modify the current rules 5.b.(4) and (5), as follows:
  - 5.b.(4) *Penalty for ~~Failure to Compete~~ No-Show at Finals*
    - (i) Any swimmer qualifying for a consolation final or final race in an individual event who fails to ~~compete~~ show up for said consolation final or final race prior to the deck referee turning over the heat to the starter shall be barred from further competition for the remainder of the meet.
    - (ii) If the ~~failure to compete~~ “No-Show” occurs on the last day that the swimmer is entered in an individual event in the meet, and no other penalty is applicable, the swimmer shall then be fined \$25.00.
  - 5.b.(5) *Exceptions for ~~Failure to Compete~~* – No penalty shall apply for failure to withdraw or compete in an individual event if:
    - (i) The referee is notified in the event of illness or injury and accepts the proof thereof.
    - (ii) It is determined by the referee that the ~~failure to compete~~ “No Show” is caused by circumstances beyond the control of the swimmer.
    - (iii) The swimmer qualified for any level of finals due to scratches of one or more original finalists.
    - (iv) The swimmer is an alternate for any level of finals.
- M/S/C (G. Cleveland, O. Melroy) For the year 2005 only, swimmers competing in the USA Swimming Junior National Championships in Irvine, California, shall be eligible for travel assistance as provided in Pacific Swimming Rules and Regulations, Section 9, on the same basis as for the U.S. Open.
- M/S/C (G. Cleveland, M. Yoshida) The determined airfare for the 2005 USA Swimming Junior National Championships in Irvine, California, shall be \$250.

- M/S/ (D. Takaki, G. Cleveland) Amend line item 58000 in the Pacific Swimming budget for 2006, allocating \$33,000 to the Zones in support of Pacific Swimming's Zone All-Star Developmental Meet. \$6000 is to be allotted to each Zone, and an additional \$3000 to the host Zone for pool, timing equipment, awards and other miscellaneous items. All disbursements must be substantiated with receipts. *Motion ruled out-of-order; should be brought to the Budget Committee when convened for 2006.*
- M/S/C (D. Takaki, T. Krohn) Pacific Swimming shall adopt all of the USA-S Top-16 Based Motivational Time Standards, to be added to the current Pacific Swimming time standards, effective immediately.

**Motions and Resolutions – New Motions:**

- M/S/C (K. Jew, M. Yoshida) That a meet be added to the 2005 Schedule; a one-day, closed invitational on Friday, July 1, 2005. This meet will be awarded to Sunnyvale (SUNN). [The Scheduling Committee recommends in favor of this motion.]
- M/S/C (M. Yoshida, J. Lanphere) To authorize the addition of a new line item #54540 to the 2005 Pacific Swimming Camps Expense Budget entitled Regional Select, and established in the amount of \$2000. Pacific Swimming will reimburse up to \$200/athlete to assist with out-of-pocket expense for airfare to attend a camp.
- M/S/F (K. Jew, D. Power) Pacific Swimming will no longer publish in the Swim Guide, those motivational standards established by USA-S; they will continue to be available on the website. Only JO and Q time standards will be published in the Swim Guide.
- M/S/F (J. Woo, D. Power) Eliminate from the Pacific Rules and Regulations, Section 3, B.3.a. "All classified meets except B meets shall be seeded on the deck. Deck seeding is recommended for B meets." Renumber para. b to a. (Swim Guide, p. 71)
- M/S/C (L. Benton, L. Rice) That the SOS Swim Team be permitted a change of name & acronym to either Pirate Aquatics (PA) or Pirate Aquatics of Modesto (PAM). The team shall make the final decision.
- M/S/C (G. Chong, M. Nygren) That the Livermore Blue Dolphins be granted a waiver from deck seeding, to pre-see a one day meet (July 24, C/B/A+).
- M/S/C (R. Waterhouse, L. Rice) That the determined airfare to the Paralympic Meet in Mt. Hood, Oregon (July 15-17) be set at \$225.

**Regular Reports:**

**Membership/Non-athlete** (Laurie Benton) –

- The SOS Swim Team requests a change of name and acronym. (see motion above)
- To date, 370 coaches and 841 other non-athletes have applied for membership in 2005, for a total of 1,211 memberships. There are 103 clubs and 3 organizations.

**Registration/Athletes** (Judy Siegrist) – Regular athlete registrations to date are 12,052, which exceeds the final total for the year 2004! Summer season registrations are 364, bringing total registration to 12,416.

**Zone 1N** (Larry Rice) – Last meeting was May 9; however, due to lack of attendance/quorum the meeting was cancelled. Next meeting will be July 11.

**Zone 1S** (Darwin Takaki) – Last met on May 11. Candidates for office were announced. Next meeting will be July 13, with elections and bidding for zone meets.

**Zone 2** (Gwenn Chong) – Last met on May 23. Discussed scheduling and nominations. A team requests authorization to pre-see a C/B/A+ meet; most of the events are sprints (see motion above).

**Zone 3** (Chris Wells) – Last met on May 16. Discussed the upcoming Zone 3 Long Course Championship meet; problems with new computers (not enough memory when running double-ended meets); authorized the North Coast clubs to purchase a new portable horn start system (Zone 3 will pay 75%, North Coast clubs will pay 25% funded by grants); introduced the new head coach of Twin Valley Aquatics, Jason Petty who has moved here from Kansas. Next meeting will be June 20.

**Zone 4** – No report received by meeting time. Report received subsequently will be forwarded to board members.

**Senior** (Scott Shea) –

- The committee is close to a recommendation of format for the senior champs meet in December; they definitely want to use Senior T&F time standards.
- Many coaches have expressed interest in an increase in the travel assistance to national meets. This request will be submitted when the Budget Committee convenes.
- The Grand Prix meet held last weekend at Standard was a very successful meet, with lots of coverage in the major newspapers. Some radio interviews conducted with athletes (Michael Phelps) helped generate paid attendance.

**Age Group** (Joe Woo) –

- The committee reviewed the Western Zone application package which will be published soon. The qualifying period is March 1 thru July 17 (last day of LC JO Champs at WEST). Cannot be extended through Far Westerns due to airline reservation requirements.
- The committee is polling PASA and MHSC for interest in bidding to host the 2007 Western Zone meet. Meet will be bid/awarded at the Convention in September.

**Coaches** (Todd Krohn) – No comment.

**Athletes** (Carole Yoshiwara) – No comment.

**Additional Reports:**

**Financial Report:**

- For the year to date, Pacific has an excess of income over expenses of \$65,755. The net worth, adjusted for our liability to USA-S and our commitment to the Salinas Community Pool Foundation, is \$1,073,766.

**Expenditure Authorizations:**

- M/S/C (C. Benton, M. Yoshida) Approve the \$3000 advanced by executive action, and authorize an additional \$3500 (total expenditure of \$6,500) for the Oakland Community Pools Project.
- M/S/C (J. Woo, J. Lanphere) Approve expenditure of the balance of the budget for Western Zone 2005. (\$96,700 - \$751 = \$95,949)
- M/S/C (S. Morsilli, R. Waterhouse) That Pacific athletes competing in the Open Water National Championships shall be reimbursed at the same level for which Pacific compensates its athletes at other national championships (\$200 + determined airfare), effective for 2005.

**Motions and Resolutions – Action on Pending Motions and Motions Held Over:**

- M/S/F That Pacific Swimming pledge to make a donation of \$250,000 to (Legal Name of MSJA Pool Foundation) to assist in the construction of a new, indoor, 50-meter pool complex; and

That the first donation of one-half the total amount shall be made at the commencement of pool construction, (but not before January 1, 2006); and  
That the final donation of the remainder shall be made at the completion of pool construction, (but not before July 1, 2006); and  
That Pacific Swimming shall make no donation until the design drawings have been reviewed and approved by Pacific Swimming; and  
That Pacific Swimming shall make no donation until the donee can produce documented proof of individual or institutional donations totaling at least \$1 Million; and  
That Pacific Swimming shall make no donation after December 31, 2007; and  
That Mission San Jose Aquatics, (PC-MSJA), shall host the Pacific Swimming Senior Winter Championships in the years 2007-2011; and  
That Pacific Swimming shall have the option to host one "Camp" at the facility at no cost, each calendar year, in perpetuity.

**Motions and Resolutions – New Motions:**

- M/S/C (G. Cleveland, M. Yoshida) Accept the recommendation of the Chair to appoint Kyla Power as second Athlete Representative to the PacSwim Board.
  - M/S/C (J. Lanphere, G. Cleveland) That Policies & Procedures Section VI Convention, 2.0 Criteria for Financial Assistance to the USA-S Convention, be changed as follows:
    - Paragraphs a. and b. – change "assistance" to "Financial Assistance"; replace c. and d. with the following:
      - c. Members of the Pacific Swimming Board of Directors, or members of Pacific Swimming with a vote at the USA Swimming House of Delegates meeting the above qualifications, shall be eligible to receive one "full share" of Financial Assistance. A "full share" is further defined as (a) the cost of transportation as determined by the Board of Directors, and (b) a per diem of 100% of the cost of a standard double room including all taxes as quoted in the convention registration forms. Should two individuals from Pacific Swimming share a room, each individual will receive 60% of the cost of the room. This per diem shall be paid for the number of days the delegate actually attends the convention but not to exceed seven days. Pacific Swimming shall pay the "Early Bird" Registration Fee providing the individual actually attends the convention. The Registration Fee may be advanced upon submission of a copy of the completed USA-S Registration Form. If the convention is not attended, the advance shall be returned to Pacific Swimming.
      - d. For individuals, with or without a vote at the USA Swimming House of Delegates, meeting qualifications b.1. and b.3. above but who are not members of the Pacific Swimming Board of Directors, Pacific Swimming shall pay the "Early Bird" Registration Fee providing the individual actually attends the convention. The Registration Fee may be advanced upon submission of a copy of the completed USA-S Registration Form. If the convention is not attended, the advance shall be returned to Pacific Swimming.
- These changes shall be effective immediately.
- M/S/ (J. Woo, G. Ng) Establish 2006 Time Standards for Age Group Meets:
    1. Leave the USA-S Motivational Time Standards listed in the Swim Guide, but clarify that they are to be used for motivational purposes only.
    2. Swimmers achieving new "A" times will be awarded "Gold Achievement" medals. (This is no different than current practice with "A" medals, except that an "A" swimmer in Pacific will have the same status as an "A" swimmer in other LSCs.)
    3. The only time standards to be used for Age Group class meets are:

- a. Bronze (equivalent to the Pacific “C” time standards – no minimum)
  - b. Silver (equivalent to the Pacific “B” times established in 2002)
  - c. Gold (equivalent to the Pacific “A” times established in 2002)
  - d. JO (equivalent to the Pacific “AA” times as adjusted by the Time Standards Committee)
  - e. Q (equivalent to the Pacific “Q” times as adjusted by the Time Standards Committee)
4. PRT is considered to be a Pacific motivational time standard similar to NRT for USA Swimming. WZCT remains for Western Zone selection time standards. None of these are to be used for meet entry time standards.
5. Implementation in the 2006 Swim Guide: 1. List age group time standards separately under columns of Silver, Gold, JO, Q, PRT, NRT. 2. List USA-S Motivational Time Standards separately for B, BB, A, AA, AAA, and AAAA. Add notes to indicate that these are national motivational time standards and are not required to be used for meet entry time standards. 3. Replace all instances of C, B, A with Bronze, Silver, Gold.
- 60-Day Motion for consideration at the August meeting.*

- M/S/C (R. Waterhouse, G. Cleveland) That the determined airfare for travel to the USA-S Convention shall be \$410.
- M/S/C That Pacific accept the award of meets for 2006 as recommended by the Scheduling Committee.

**Motions and Resolutions:** (none)

**Reports of Officers:**

**General Chairman** (Clint Benton) – Pacific Swimming continues to be one of the top LSCs in USA Swimming, but the needs of our members are changing and Pacific must make changes to accommodate those needs. This will be the challenge of the new Board taking office in September.

**Administrative Vice-Chairman** (Harrison Race) – the various Pacific committees, of which this office is an ex-officio member, are performing their duties well.

**Treasurer** (Fred Siegrist) – For the year to date, Pacific has an excess of income over expenses of \$65,755. The net worth, adjusted for our liability to USA-S and our commitment to the Salinas Community Pool Foundation, is \$1,073,766.

**Senior** (Scott Shea) – Scott is working with several senior coaches to stimulate the senior program.

**Age Group Vice-Chairman** (Joe Woo) – Selection for the annual Quad Meet was changed from performance at a single meet to performance over a period of time, similar to the qualification period for Western Zone.

**Zone Reports –**

- Zone 4 (Dave Hoover) – the Zone is suffering great turmoil over the way they have been treated in Pacific, and is considering whether to remain in our LSC or withdraw. They have voted to stay in Pacific for another six months, to see if the issues can be resolved. A major issue is the way their officials are treated, but also of concern is that many major PC meets are a great distance for travel for their swimmers (and coaches and families), meets hosted in their area are not supported by most teams in the LSC, travel reimbursement by PC for national competition often does not reflect the real cost of travel from their area, and meetings in PC are difficult to attend due to time and location.

**Athletes** (Carole Yoshiwara) – two issues are currently of concern to the athletes in Pacific:

- The duration of long course season is half that of the short course season; high school swimmers have even less time. They consequently have a greatly reduced opportunity to qualify for meets such as Western Zone and Far Westerns. Pacific should consider alteration of the time period for long course meets.
- The new junior times are a big jump from sectional times, and are significantly faster than U.S. Open times. There needs to be a step in between.

**Camps** (Mary Yoshida) – presented a written report on the progress of camps so far in 2005; one has been cancelled (the Zone 4 Stars & Future Stars Camp). Attendance this year (146 athletes at 4 of 5 camps for 2005) is up significantly over the previous four years (2001 – 133, 2002 – 131, 2003 – 130, 2004 – 111). All of the volunteers have been greatly appreciated – coaches, camp managers and directors, the members of the Board of Directors who have been speakers at the parents meetings, and the athlete speakers.

**National Legislation** (Anneliese Eggert) – there is quite a bit of legislation this year, from many committees and the task force on governance. All will be posted on the website by July 3.

**Prior Business:** none

**New Business:** none.

**Age Group** (Joe Woo) –

- The Western Zone team has been selected. The Committee is in the process of notifying the swimmers. The team will NOT be posted on the website until after the meet has concluded, per the Pacific Swimming privacy policy.
- The Far Western Long Course meet will be held at Concord July 27-31. Coaches have requested relays for the 15-18 age group. The Committee has approved this request, but relays will swim for time only. The time standard will be the same as 17-18.
- Joe Woo and some coaches conducted briefings for parents at the recent JO meet, to promote the Western Zone team.
- For future meetings, the AG Com. will consider a policy of accepting nonconforming times instead of using converted times for FWLC.

**Additional Reports:**

**Camps** (Mary Yoshida) –

- USA-S has agreed to continue the funding for LSC camps<sup>0</sup> for one more year.
- Beginning in 2006, Regional Select camps will be replaced by Zone Select camps.
- Selection for the Jr. Leadership Camp has been extended through FWLC; the camp is about half full now.

**Finance and Audit** (Joyce Lanphere) –

- The first Budget Committee meeting will be held on Saturday, October 8, at 10:30a, at the San Lorenzo Community Church (where regular BOD meetings are held). The meeting is expected to last two hours. All committees are requested to start preparing budget requests with background information.
- This budget committee will need to consider the athlete registration fee to be charged for 2007. Pacific has absorbed the increase from USA-S over the last two years.

**Officials** (Gerry Ng) – There has been a change to the wording of the policy (102.10.10) regarding the prohibition of pace devices. Pacific Masters policy has better wording. Officials will request swimmers to not wear their watches.

**Schedule** (Kim Jew) –

- The Committee has reviewed bids submitted for the second round. See motions above.
- The July 4<sup>th</sup> weekend remains a protected weekend (the Ukiah bid was received and approved in the second round).

- Regular athlete registrations to date are 13,020. Summer season registrations are 2,400, bringing total registration to 15,420.
- All re-registration packets have gone out.

The meet will be held at the same place and time; this is a wonderful facility with two 50-meter pools, electronic takeoff pads, etc.
- At Nationals, there were five officials from Pacific. At Juniors, there were also several officials from Pacific.

- At the Western Zone meet, Pacific placed a close second.
- The Western Zone is compiling historical records.
- The Quad Meet will be held Jan 21-22 at the Nike Camp in Beaverton, OR.

ZONE 4 TASK FORCE REPORT TO PACIFIC SWIMMING  
BOARD OF DIRECTORS  
AUGUST 24, 2005

There has been a very active interchange of information within the task force members and several additional interested/involved individuals.

The concerns can be divided into 2 basic groups – location impacted issues, and officiating issues.

As for the officiating issues, there are a number of things underway now which should enable most of these issues to be addressed and probably resolved. Since some of these issues are relatively sensitive, they will not be presented before this body. When the solutions have been developed, you will be advised in general terms.

The so-called location issues can be grouped into a few categories:

- Local participation
  - There are 9 teams in the zone: 1 is a university team, 1 is a summer club, neither of which participates in Zone functions.
  - Of the active 7, 2 rarely participate, leaving 5 participating clubs.
  - From these 5, the zone needs to come up with 6 to 8 officers, coaches for all-start teams, camp coaches, etc. The result is a few very overworked volunteers who easily become burned out.
  - It has been suggested that Zone 4 might merge with another zone, such as Zone 2. However, that does not really solve most of the other problems, and it is unlikely Zone 2 personnel could provide any better support that the LSC now provides.
- Financial aspects
  - Zone 4 has very limited funds – about \$5000 in its account.

- Zone 4 is unable to provide financial assistance to athletes going to Nationals, Juniors, or Western Zones, or any other meets such as Sectionals or Far Westerns. Zone 4 provides limited assistance to athletes in the Zone 1-2-3-4 All-star meet.
  - In reality, almost all swimmers going to these type of meets come from only 1 or 2 of the 9 clubs which makes for obvious discontent.
  - PC will need to look at ways to assist Zone 4 in finding additional funding for these types of activities. Some suggestions have included reducing the amounts of meet entry fees remitted to Pacific, providing a lump sum grant annually, etc.
  - Perhaps the financial support to be provided for the Zone 1-2-3-4 All-star meet, since Zone 4 must travel extreme distances every year except the year they host the meet, could be adjusted to provide more travel cost off-set funding.
  - Pacific needs to reconsider the amount of travel assistance for Nationals, etc. when the costs for Zone 4 athletes are out of line with the rest of the LSC athletes.
- Zone 4 participation at Pacific Board of Directors meetings
    - There are 2 basic issues here, cost, and time.
    - Depending on where the person is located, it requires 4 to 5 hours travel prior to a meeting plus the same afterwards, and maybe an overnight stay for someone to attend our meetings. This involves significant cost as well as time.
    - Among several suggestions, could the LSC conduct its BOD meetings in each of the Zones sometime during the year? Would enough of us travel to such locations to be able to conduct meaningful business?
    - The LSC could provide financial support to someone from Zone 4 to come to meetings held here, but what about the time impact – lost wages, or whatever?
- LSC Championship Meets
    - All such meets are held, generally, somewhere in the Bay Area, again making it an expensive and significant time factor for Zone 4 athletes and families to participate with the consequence that only those who are upper level swimmers are likely to participate.
    - Could it be a requirement that such a meet is awarded to Zone 4 every few years. In the past, there has been little support from the “lowland” clubs for such meets so that aspect will need to be addressed.

There are a few additional less significant issues, but you have a taste for the situation now. I am convinced that the Zone 4 people raising these issues are more than willing to work with us to find workable solutions to most of the problems that have been presented. Some fixes can be implemented in the near term but some may take some time to fix.

The task force will continue to work on this assignment.

**Treasurer:**

- \$176K of expense this month, of which \$166K was pass-thru of fees due to USA-S.

**Reports of Officers:**

**General Chairman** (Don Power) – none.

**Safety** (Mike Metcalf) – presented a written report.

- At the national level, in the previous nine months, there has been a significant increase in the number of reported incidents. During the same period there were 61 reported incidents in Pacific, a 27% increase over 2004.
- Two incidents of head injury due to improper diving technique were reported in 2005; it is apparent that coaches continue to ignore the need to train swimmers during practice.
- There was a significant increase in the number of asthma attacks reported in 2005.
- A page has been added to the new Pacific website for Safety.

- Training for meet marshals is a positive step toward reducing accidents. Zone 1S was commended for conducting training sessions at the beginning of meets.
- Swim meet safety during electrical storms continues to be an issue. (See the Safety page on the website for lightning safety awareness)
- Coach registration is mandatory, and requires safety training. Sources for training opportunities are posted on the website. Referees are encouraged to check for visible display of current coach registration at swim meets.
- The USA-S Safety Education Committee may be disbanded; however, Mike will continue to be a member of the Committee until this may happen.

**Camps** (Mary Yoshida) – presented a written report on the 2005 camps.

- Five of the planned six camps were held – all with high interest.
- New format of the Camps Committee for 2006, with members from all zones.
- Need two more coaches (at least one female coach) for the 11-12 AA camp, Feb 4-5 in Pacifica.

**Commendation** (H. Race, D. Power) – Rick Beebe has been an excellent webmaster and is very proactive in alerting members to articles of current interest to the swim community. The recent article in the San Francisco Chronicle was of particular note.

**Zone Reports** – No reports were presented at the House of Delegates meeting.
