Conduct of Meets</b></p> <p><b>4. <del>Positive Check In</del> Scratching from Bonus and Consolation Finals and Finals</b></p> <p><i>a. Athletes may check in or declare their intent to compete in finals for that day at the beginning of competition for that day. Athletes may scratch or declare their intent to scratch a final event, or multiple final events at the beginning of competition for that day.</i></p> <p><i>b. Athletes shall check in or declare their intent to compete in consolation finals or finals within 30 minutes of the announcement of qualifiers. In the case where an athlete declares their intent to compete they shall declare their final intention within 30 minutes after the announcement of qualifiers for their last individual preliminary event. Athletes not returning to declare their intention shall be seeded into the event. Any athlete qualifying for any level of finals in an individual event who does not wish to compete shall scratch within 30 minutes after the announcement of qualifiers. During this period, qualifiers may also notify the referee that they may not intend to compete in consolation finals or finals. In the event of a withdrawal or barring of an athlete from competition, the referee shall fill the consolation final or final when possible with the next qualified athlete(s). First and second alternates shall be announced with the final qualifiers. Alternates shall not be penalized if they are unavailable to compete in the finals. In the event of a withdrawal or barring of an athlete from competition, the referee shall fill the bonus final, consolation final or final when possible with the next qualified athlete(s). First and second alternates shall be announced along with the final qualifiers. These alternates shall not be penalized if they are unavailable to compete in the finals.</i></p> <p><i>d. Relay only athletes will be funded at 50% of the published travel support amount.</li> <li>• <del>Coaches must have attended the meet.</del></li> <li>• The club must have a copy of their <b>Team Travel Policy</b> on file with Pacific Swimming.</li> <li>• All athletes who travel must sign a <b>Code of Conduct Form</b> prior to the trip (Pacific Swimming's or equivalent).</li> <li>• All clubs, coaches, and athletes must be in good standing with Pacific Swimming and cannot have any outstanding debts or obligations.</li> </ul> <p>Athlete eligibility requirements:</p> <ul style="list-style-type: none"> <li>• Must compete attached to a Pacific Swimming club or unattached as a Pacific Swimming member.</li> <li>• The level of support will be based upon an athlete's continuous registration in Pacific Swimming (see chart below).</li> <li>• <b>High school/non-collegiate</b> - must have competed in at least one (1) Pacific Swimming meet each season.</li> <li>• <b>Collegiate athletes</b> - must have been Pacific Swimming members prior to college and return to Pacific Swimming in the summer.</li> <li>• <b>Post Grad</b> - those who were not members of Pacific Swimming prior to college, their "clock" begins when their collegiate eligibility ends. 				<p><b>Source of AQI:</b></p> <p>Reliable website(s) should be used for AQI information. A primary site and a secondary (backup) site that provides AQI information on or near (5-15miles) to the swim venue should be used. AQI indices of any location is quite dynamic and can vary greatly depending on weather patterns. Specific location data should be used as the geographic peculiarities of the Bay Area can greatly affect neighboring locals with vast differences in microclimate.</p> <p>The preferred primary site is AirNow.gov (an EPA site). A secondary site (purpleair.com) should also be established as the EPA site could be slowed or completely down due to traffic volume especially before and/or during swim meets. A single point of contact should be established and made responsible for providing the AQI data. Continued (hourly) monitoring should be done if the AQI of the venue is between 101-150.</p> <p><b>Decision process:</b></p> <p>Meet host should check with meet venue facility manager to verify that the venue will be open and the criteria the facility manager will follow for closing the venue.</p> <p>Prior to the meet, after obtaining clarification from the facility manager regarding closure of the swim venue, the responsibility to decide whether to hold the meet or not should be a joint decision between the Meet Referee and the Meet Host.</p> <p>During the meet, a Meet committee consisting of Meet Referee, Meet host, coach(s) and athlete should be established to review AQI monitoring data and to recommend the course of action. The AQI data and common sense should be used in the decision process. Always refer to AQI Index using the EPA recommendation as a guideline.</p> <p><b>Timing and Communication of Decision:</b></p> <p>If poor air quality situations occur days before the meet, Meet host and Meet Referee should start monitoring AQI at least daily before the meet, and have an action plan in place. This should include a proposed cutoff limit numerical value of AQI.</p> <p>Deadline for decision to hold a meet or not should be made as early as possible giving affected parties such as swimmers, parents, coaches, officials ample time to plan.</p> <p>If the decision is to be made the day of the meet, decision and announcement should be made no later than 6:00 AM the day of the meet.</p> <p>A single website should be the single information source. Secondary websites should only provide links to the primary</p>
