SANCTION: Held under USA/Pacific Swimming Sanction No. **13-146**

In granting this sanction it is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

NOTICE: By entering this meet, the athlete or his/her guardian consents to the publication, via electronic, print or other media, information and/or imagery related to their participation at this meet. Such information and imagery may include, but is not limited to, photographs, video, web casting, television, psych sheets and live meet results.

USE OF AUDIO AND VISUAL: Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the meet referee. Use of any audio or visual recording electronic devices, including but not limited to film and digital cameras, cell phones and tablets, is not permitted in changing areas, rest rooms or locker rooms. Violation of this recording prohibition may result in ejection from the swimming pool facility by the meet referee or his/her designee

Meet Marshal: A team attending the meet will be assigned this duty and will be posted at the meet.

CERTIFICATION MEET: Officials wishing to be evaluated must apply to the Meet Referee before the meet by email or when they first arrive at the meet and attend pre-session meetings. Briefing will occur one hour before the start of Trials and Finals. Officials dress for finals is a white polo shirts/blouse, blue long pants or skirts, and closed white athletic shoes. For a N2 evaluation to be valid it must be done over 3 sessions in the position; N3 evaluations must be done over 4 sessions in the position. Recertification evaluations must each be done over 2 sessions, however, the official must work at least 4 sessions at the meet for the recertification evaluation(s) to be valid. The application form can be found on the Pacific Swimming Website.

LOCATION: John F. Cunningham Aquatic Complex, 801 Heartwood Ave., Vallejo, CA.

From I-80 East onto Georgia Street; from I-80 West, RIGHT up over freeway onto Georgia Street. Go east on Georgia Street, past (3) stoplights. Turn LEFT on Heartwood to pool. From Contra Costa, take I-680 NORTH to I-780 NORTH. Exit from I-780 at Columbus Parkway. Turn LEFT on Georgia Street. Turn RIGHT on Heartwood. Pool is on the left side. **Pool parking lot is for officials only who are working the meet. Those parking in improper areas will be ticketed by V.P.D and may be towed.**

COURSE: Outdoor heated pool: 25 yards, with up to 8 competition lanes expandable to 15 lanes. Separate warm-up and warm-down area available throughout the meet. The minimum water depth measured in accordance with Article 103.2.3, is 6' at the start end and 6' at the turn end for session A. The minimum water depth measured in accordance with Article 103.2.3, is 5' at the start end and 5' at the turn end for session B. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

TIME: Friday Night session will begin at 5:00pm with warm ups from 3:30 to 4:45. Prelims Session "A" and "B" for Saturday and Sunday **will begin at 9:00 AM** with warm ups between 7:30 AM and 8:45 AM. Prelim Session A will be swum in the deep end of the pool and Prelim Session B will be swum in the shallow end. Finals will begin no sooner than one hour after the completion of Prelims Session "A and "B", the exact time to be announced each day.

RULES:

- Current USA/Pacific Swimming rules will govern the meet. Pacific Swimming warm up procedures will be in effect. A copy of these procedures will be posted at the Clerk of Course.
- Swimmers may compete in only one (1) event on Friday and three (3) events on Saturday and Sunday plus relays.
- If conditions warrant it, the Meet Referee with the concurrence of the Meet Director, may require a mandatory scratch down or close the meet to further entries per the following statement: When the number of splashes either meets or exceeds the estimated timeline, all entries will be closed and notification posted on the Swim Connection website, the VJO website, and Pacific Swimming website.
- Entry forms and payments received after the close of meet will be returned with an explanation.
- In the event of a mandatory scratch down, immediate cash refunds will be made.

- Swimmers in the 1000 and 500 yard freestyle events must provide their own timers and lap counters.
- The 11&O 400 IM, 1000 Free, 9&O 500 Free, 13&O 200 Fly, 200 Breast and 200 Back, 9-10 100 Fly, 11-12 100 Fly, all 8&U events, and all relays will be swum as timed finals.
- At the discretion of the Meet Director and Meet Referee, the 400 IM, 500 free and 1000 free may be combined or swum alternating girls and boys heats.
- All other events will be swum as trials and finals, with all preliminary heats swum during one of two morning sessions and all finals swum as a third session in the afternoon.
- The 8 fastest times from trials, after scratches, will qualify for finals.
- The 8-un and 9-10 relays will be swum at the conclusion of Prelim Session "B." All other relays will be swum during the finals portion of the meet unless noted.
- Relay entries may be deck entered only. **Relay entries will be due at an announced time each day.** Each team may enter as many relays as possible but only the two fastest relays swum from each team, will be scored or awarded. Teams will be required to pay for all relay entries that are not scratched prior to the relay entry deadline each day.
- ALL SWIMMERS IN RELAYS, INCLUDING THOSE SWIMMING RELAYS ONLY, MUST BE PRE-ENTERED IN THE MEET AND HAVE COMPLETED A CONSOLIDATED ENTRY CARD.**

UNACCOMPANIED SWIMMERS: Any USA-S athlete-member competing at the meet must be accompanied by a USA Swimming member-coach for the purposes of athlete supervision during warm-up, competition and warm-down. If a coach-member of the athlete's USA-S Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the swimmer or the swimmer's legal guardian to arrange for supervision by a USA-S member-coach. The Meet Director or Meet Referee may assist the swimmer in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the athlete's USA-S Club Member-Coach.

RACING STARTS: Swimmers must be certified by a USA-S member-coach as being proficient in performing a racing start, or must start the race in the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

RESTRICTIONS:

- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, or standing areas and in all areas used by swimmers, during the meet and during warm-up periods.
- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No glass containers are allowed in the meet venue.
- No propane heater is permitted except for snack bar/meet operations.
- Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged.
- All shelters must be properly secured.
- Pop-ups and tents will not be allowed on deck except at the west end of the pool. For Fire and Safety purposes, the coaches' area is for coaches only. Swimmers/team members may check in with their coaches but cannot stay there.

ELIGIBILITY:

- This meet is open to Zone 3 registered swimmers ONLY of Pacific Swimming.
- Zone 3 swimmers over 18 years old **may**, with the exception of relays, compete in the 13-OV events, score and win awards and must meet the 17-18 time standard for each entered event.
- Swimmers must be current members of USA-S and enter their name and registration number on the meet entry card as they are shown on their Registration Card. If this is not done, it may be difficult to match the swimmer with the registration and times database. The meet host will check all swimmer registrations against the SWIMS database and if not found to be registered, the Meet Director shall accept the registration at the meet (a \$10 surcharge will be added to the regular registration fee). Duplicate registrations will be refunded by mail.
- Entries with "**NO TIME**" **will be accepted.**
- Entry times submitted for this meet will be checked against a computer database and may be changed in accordance with Pacific Swimming Entry Time Verification Procedures.
- Disabled swimmers are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding any special accommodations on entry times and seeding per Pacific Swimming policy.
- The swimmer's age will be the age of the swimmer on the first day of the meet.

ENTRY FEES: \$2.75 per individual event, \$8.00 participation fee per swimmer. \$9.00 per relay. ****Note, relay only swimmers ARE NOT required to pay the participation fee. All entry fees MUST be included with entry.**

ONLINE ENTRIES: To enter on-line go to <http://ome.swimconnection.com/pc/VJO20130809> to receive an immediate entry confirmation. This method requires payment by credit card. Swim Connection LLC charges a processing fee for this service, equal to \$1 per swimmer plus 5% of the total Entry Fees. Please note that the processing fee is a separate fee from the Entry Fees. If you do not wish to pay the processing fee, enter the meet using a mail entry. **Entering online is a convenience, is completely voluntary, and is in no way required or expected of a swimmer by Pacific Swimming.** Online entries will be accepted through Wednesday, **July 31, 2013**

MAILED OR HAND DELIVERED ENTRIES: Entries must be on the attached consolidated entry form. Forms must be filled out completely and printed clearly with swimmers best time. Entries must be postmarked by midnight, Monday, **July 29, 2013** or hand delivered by 6:30 p.m. Wednesday, **July 31, 2013** to 301 Angelina Way, Vallejo, Ca 94589. No late entries will be accepted. No refunds will be made, except mandatory scratch downs. Requests for confirmation of receipt of entries should include a self-addressed envelope.

CHECK-IN: The meet will be deck seeded. Swimmers must check-in at the Clerk of Course. **Close of check-in for all events shall be no more than 60 minutes before the estimated time of the start of the first heat of the event.** No event shall be closed more than 30 minutes before the scheduled start of the session. Swimmers who do not check-in will not be allowed to compete in the event.

SCRATCHES: Pacific Swimming scratch rules will be enforced. A copy will be posted at the clerk-of-course. Swimmers entered in an individual event in a Trials and Finals meet that is seeded on the deck that have checked in for that event, must swim in the event unless they notify the clerk of the course before seeding for that event has begun that they wish to scratch. Failure to swim an event will result in being barred from rest of his/her events that day including relays. If the swimmer qualified for a final before missing an event they may swim that final. The penalty will not apply if the Head Referee accepts proof that the failure to swim has been caused by illness, injury, or other circumstances out of the swimmer's control. Any swimmer qualifying for a final race in an individual event, who fails to show in said final race, prior to calling the alternate, shall be barred from further competition for the remainder of the meet. If the No-Show occurs on the last day that the swimmer is entered in an individual event in the meet, and no other individual event penalty is applicable, the swimmer shall then be fined \$25.00. Swimmers have 30 minutes after the results of an event are announced to scratch or declare their intent to scratch.

AWARDS: Awards will be given to the coach or team representative at the end of the meet.

Finals - Pins 1st through 8th.

Relays - Pins 1st through 3rd.

Team trophies to 1st through 3rd place.

SCORING: Finals – 11, 9, 8, 7, 6, 5, 4, 3 / Relays – 22, 18, 16

ADMISSION: Free. A 3-day meet program will be available for a fee.

SNACK BAR: A snack bar will be in operation during the meet on Saturday and Sunday only.

HOSPITALITY: Lunch and limited hospitality will be available to all working officials and coaches.

MISCELLANEOUS: No overnight parking is allowed. Facilities will not be provided after meet hours.
