10. By-Law Changes:

A. Section III Paragraph C (Move month of elections to July from June if we have meetings only in odd months.)

ELECTION OF OFFICERS

- 1. Nominations shall be made in May and elections held in July every year.
- 2. Term of office shall commence on the first day of September.
- 3. Each nominee, if not present during nominations, must give his/her consent to serve, prior to the election.
- 4. A nominee will be elected by receiving a majority vote cast by the authorized voting members present at the <u>July</u> meeting.
- B. Section IV Paragraph C (Are the incentive's needed? Suggest deleting them.)
 Attendance of team representatives shall be taken at each meeting and reported in the minutes of that meeting.

 Incentive for meeting participation shall be as follows:
 - Teams represented at 0-3 meetings annually will pay the full \$100 for membership dues for the following year.
 - Teams represented at 4-6 meetings will pay\$50 for membership dues for the following year.
 - Teams represented at 7-9 meetings will pay \$25 for membership dues for the following year.
