JOB TITLE: Director of Aquatics

DEPARTMENT: Swimming Pool

SUPERVISES: Pool Staff – Lifeguards – Swim Coaches

REPORTS TO: Clubhouse Manager/General Manager

JOB SUMMARY: Supervises lifeguards; supervises safety, cleanliness and aesthetics of Club swimming

facilities. Manage summer swim programs and activities including Swim lessons, Swim Team and other swim programming; schedules and coordinate swim meets. Conduct swimming classes and individual swimming lessons in a safe and responsible manner. Observes Club safety rules and guidelines. Coordinate and manage summer

youth camp and programs.

JOB TASKS:

General

- Maintains a courteous, polite and helpful relationship with all members and guests
- Working knowledge Club policies and guidelines as outlined in the Burlingame Country Club Employee Handbook and Emergency Action Plan.
- Create a positive image by keeping physically fit and well groomed.
- Hires, trains, supervises and evaluates all aquatics staff, lifeguards and coaches
- Completes and processes all pool staff paperwork and payroll in a timely manner.
- Formulates weekly work schedules and rotation schedules for all pool employees
- Delegate responsible lifeguards to open and close the facility as dictated by hours of operation.
- Maintains correct payroll records
- Enforces club rules of safety and conduct
- Plans and directs special events and represents the club in activities as required
- Registers members at pool and charges for all guests, lessons, etc.
- Develops an annual operation and staffing budget to be approved by the General Manager; takes corrective actions as necessary to assure that budget goals are attained
- Orders and sells swim suits, suntan oil, sunglasses and other pool accessories; keeps accurate
 accounting records of sales.
- Coordinates Swim Banquet programs and awards
- Attend and participate in Swimming Pool Committee meetings
- Report any unusual situations to the Clubhouse Manager.
- Monitors with the maintenance staff proper chemical balance in pools and monitors mechanical equipment in coordination with the club's maintenance department
- Act as an instructor and lifeguard when necessary
- Maintains and keeps all necessary records concerning pool attendance, pool chemicals ph and chemical levels, accident reports, problem-member reports, class records, lifeguard and instructor schedules, time cards, etc.
- Alert maintenance department of all problems and need which cannot be solved by existing staff.

- Develops and implements pool safety program and schedules staff to provide adequate protection for members and their guests.
- Employs only those methods and teaching techniques outlined/approved by the Red Cross
- Assist in rendering first aid according to the standards established by the American Red Cross and American Heart Association.
- Performs other tasks as requested by management

Swim Program:

- Promotes and Coordinates the summer swim team program
- Writes seasonal swim communications to members about lesson dates, class times and fees
- Writes and sends post-season letter to members to encourage the continuation of building their children's skills through lessons
- Keeps attendance records of members and children attending lessons
- Arranges a program of private and group swim, water polo, diving lessons or any other programming
- Charges members for all lessons
- Orders and distributes swim team uniforms
- Reads lineups during swim meets

Youth Programs:

• Develops, promotes and manages swim portions of summer youth and sports camp programs

Assistant Pool supervisor/head guard, Lifeguards, Swim/Camp counselors

Required Education:

Must be 18 years of age or older

Must have Red Cross Lifeguard Certificate

Preferred:

American Red Cross Progressive Swimming Instructor Certificate

American Red Cross Basic First Aid,

American Red Cross CPR Card including training on AED units

Working Conditions:

- Working conditions are often slippery and wet.

Special Requirements:

- Must be able to work a flexible schedule and/or overtime if needed.
- Must be able to work weekends and holidays.
- Must work well with others as a team and help co-workers when needed.
