#### PROPOSED SWIM MEET SCHEDULING PROCESS - Final Version, rev 1/7/2012

#### SECTION III - SWIM MEETS

In setting up and managing our swim meets, we should keep the following in mind:

- 1. We should do what is right for the swimmers.
- 2. The host club should not have to lose money.

#### 1.0 DUTIES OF THE SCHEDULING CHAIR

The Zone 1 South Scheduling Chair shall:

- 1. Represent Zone 1 South on the Pacific Swimming Scheduling Committee.
- 2. Assemble a scheduling committee to define and schedule Zone 1 South meets in compliance with the requirements in section 2.0 below. The scheduling committee shall consist of no more than 5 members and shall be comprised of the Scheduling Chair, one or more athlete representatives, and one or more coaches. Remaining members should be considered from Chairs or alternates of the Officials, Age Group, and Sanctions areas, as well as, other strongly interested people.
- 3. Obtain Board approval of the swim meet schedule.
- 4. Oversee the swim meet bidding process.
- 5. Interface with host clubs on any clarifications or changes to their meets.

#### 2.0 REQUIREMENTS FOR THE SCHEDULING COMMITTEE

The scheduling committee is responsible for developing each year's meet schedule for Zone 1 South.

- 1. The meet schedule must not violate any restrictions imposed by Pacific Swimming and shall cover an entire calendar year.
- 2. Any restrictions imposed by the scheduling committee on meets must be documented with the proposed schedule. For example:
  - a. Whether a dual venue meet must have the same events at each location.
  - b. Whether a dual venue meet is divided by area with a host in each area and clubs assigned to each meet.
  - c. Whether a meet must have only a certain set of events.
- 3. Without specific restrictions having been specified, a host club may add additional events to their meet as long as the original meet requirements are met.
- 4. Up to one meet per hosting club may be scheduled for which there will be no bidding. These should be unique, fun meets such as the ALMA Relays.
- 5. The Sanctions Chair and the assigned Head Meet Referees shall check the meet sheets for compliance with any restrictions imposed by the scheduling committee.
- 6. The scheduling committee shall obtain approval of the Board for the proposed schedule, making changes as determined by the Board.

#### 3.0 SWIM MEET SCHEDULING AND BIDDING PROCESS

A scheduling committee is to be formed in March.

#### PROPOSED SWIM MEET SCHEDULING PROCESS - Final Version, rev 1/7/2012

The scheduling committee presents the proposed meets and schedule to the Board in May.

At the July Board meeting:

- 1. The Board approves the meets and the schedule with or without additions or changes.
- 2. Clubs draw numbers for the order of bidding on meets.
- 3. Bidding for meets continues until all meets are taken or there are 2 rounds of "no bids".
- 4. The schedule is re-opened to add or change meets on the schedule.
- 5. Bidding on host added or changed meets proceeds in the same order as the original bidding.
- 6. Clubs hosting meets within 2 weeks before and after any added or changed meet must give approval before that meet can be approved by the Zone 1 South Board.
- 7. Meet additions, changes, and bidding continue until a motion to close the schedule is seconded and passed.
- 8. Detailed meet criteria for any added meet shall be defined by the scheduling committee and the host club before the next Board meeting.

The Scheduling Chair publishes the results for the Board and for Pacific Swimming.

Open meets are available on a first come basis by contacting the Scheduling Chair with final decision by the Scheduling Chair and elected officers. A different meet may be proposed than is on the schedule, but requires approval from clubs hosting meets within 2 weeks before and after the requested meet.

#### 4.0 RETURNED MEETS

The host club shall inform the Scheduling Chair as soon as they decide they cannot host a meet that they were awarded.

The Scheduling Chair shall notify the Board that the meet is available on a first come basis with final decision by the Scheduling Chair and elected officers. If the new host wishes to change the meet, then approval is required from the clubs hosting meets within 2 weeks before and after the requested meet.

#### **5.0 CHANGE PROCESS**

Any changes not covered by the above process, or any other situations that need to be resolved, shall be brought to the Board for approval. If it must be handled before the next Board meeting, the Scheduling Chair and elected officers shall handle it by majority vote. The results of such voting shall be documented by the Chair in the minutes of the next regularly scheduled Zone 1 South Board meeting.

#### V. AWARDING OF ZONE MEETS

The Zone Chairman shall appoint a Scheduling <u>Chair Chairman</u> who shall represent the Zone on the Pacific Swimming Scheduling Committee, and who shall form and oversee a <u>committee to</u> develop the schedule for Zone awarded meets., develop and maintain the <u>procedures for informing the Zone clubs / teams of the schedule and of the procedures for bidding on the Zone awarded meets.</u>





## **Computer Operator Software**

- Dolphin supported as primary timing system in current Hy-Tek Meet Manager (extra fee to use as backup watches)
- Need to get SAMMS to read Dolphin files
- Supported by Easy Meet Manager (to be called Touchpad) at least for single-ended meet
- Real-time merging of 2-ended meet results?
  - o Hy-Tek requires pro network option
  - o Hy-Tek with pro network can merge Colorado 5 and Dolphin results

# **DOLPHIN TIMING SYSTEM PROPOSAL for Z1S**

#### **Motion: Independent Reconciliation of Bank Statements**

We should remove the requirement to send the Zone 1 South bank statements to the Chair or his appointee for an independent reconciliation.

Discussion: The requirement was added to our procedures in order to pass audits. Pacific Swimming no longer requires this. Electronic copies are placed in DropBox each month from which TeamWorks, Inc. does an independent reconciliation.

#### **Motion: Payment to Store Trailers**

We should change the wording authorizing payment for storage of timing trailers to the following:

Zone 1 South may pay a reasonable fee to store our timing equipment.

Discussion: The current wording is: "Zone 1 South may pay \$50 per month for storage space for the timing trailer that used to be kept on Bill Cunningham's property." Though the \$50 rate has been extended for another year, this should not have to be brought up at the Board each time there is a rate increase. We also should be more open to storage of the rest of our timing equipment in case the need arises.

#### Motion: \$100 a day Chief Timing Judge Penalty

We should remove the penalty of \$100 per day for a host club who does not provide a Chief Timing Judge.

Discussion: Though the intent of the motion was good, enforcement has not been consistent and may not be necessary. Bill Cunningham prefers to do the Chief Timing Judge job while doing his Colorado operator job. Other Colorado operators won't let the meet proceed until a Chief Timing Judge is in place.

#### Motion: Modifying the 60-day Dolphin motion

I intend to modify the existing motion to request \$6500 instead of \$13,000 to purchase a 10-lane Colorado Dolphin timing system and laptop computer, but no wireless 4-line scoreboard.

Discussion: This separates the objective of improving our scoreboard capability from that of getting an additional timing system. The price would be contained within the existing 2012 budget of \$7500 allocated for timing equipment. This system would allow us to schedule more single-ended meets while encouraging our smaller clubs to host those meets. More discussion at the Board Meeting.

## Motion: Fee for use of the Dolphin Timing System

If the motion for purchase of a Dolphin timing system passes, I intend to make the following motion to set its rental fee.

The Dolphin Timing System shall be available at no charge to Zone 1 South clubs hosting single-ended meets. This includes single team, dual, and tri meets, as well as, larger Zone 1 South bid meets.

Discussion: Ordinarily, we charge \$125 per day for a trailer. A lot less equipment is involved in this case, plus we are trying to encourage clubs to offer more swim meets of the type that may be less profitable.
