Read the Pacific BOD minutes for several changes to JO's: Dropping 1000 and 1650 from Winter JO's, 500 Free and 400 IM to be timed finals. Meet likely in Moraga with Pacific hosting and clubs bidding for jobs with pay based upon the job.

USA-S probably will have their budget approved by the BOD and not the HOD. LSC's likely will follow. This needs a By Laws change.
