3. Rule Books for Officials.

Motion (Lucille Glassman/second Carol Waln): budget \$150 for 75 mini USA Swimming Rules Books for Officials. PASSED.

4. Athlete Safety

Motion: (Lucille Glassman/ second Phil Harter): To create a position in Zone One North to serve as an impartial ombudsperson to receive, investigate and refer to appropriate authorities as necessary, complaints and allegations of improper behavior perpetrated upon any member of Pacific Swimming or USA Swimming.

Motion To Pacific Swimming: (Lucille Glassman/second Mario Osorio): To create a position in Pacific Swimming to serve as an impartial ombudsperson to receive, investigate and refer to appropriate authorities as necessary, complaints and allegations of improper behavior perpetrated upon any member of Pacific Swimming or USA Swimming. Motion passed by email vote on March 23 (17-0.)

Zone One North chair reported that several senior officials (names not included) are "appalled by lack of action from the LSC and request an apology from the LSC to the swimmers who were mistreated or abused by adult members of USA Swimming"

5. Meet Timelines

Recommendation to use the estimated timeline instead of the swimmer count for determining when to close a meet to entries

6. LSC News

Zone One North officials would like to see Pacific Swimming adhere to USA Swimming 4 and 8 hour rule guidelines. Zone One North officials are unhappy that Pacific Swimming Junior Olympics and Far Westerns are in violation of these rules. The officials would like to see penalties imposed on teams in violation of these rules.

Action Item: find a Zone One North official to be added to dual-venue committee.

Officials want some changes to schedule including "concept meets' and more senior swimming. Many zones indicating that pool rental fees are too high and prohibit running a "standard meet". There will be a proposed motion to the LSC Board of directors to change check-in requirements from 30 minutes prior to 60 minutes prior.

7. Meet Personnel

Pacific Swimming is recommending that meet referees should not be from the host team. This is especially noted in dual meets.

8. Clinics

PSL and PASA need to schedule official's clinics. Koa has had no officials in 2010 or 2011. DCD would like to host a clinic.

9. High School

There is a lack of officials at high school officials at high school dual meets. High School coaches need to contact Lucille to schedule officials for dual meets.

- d. June 23 and 24 has been approved as open meets. The meet format might not be restricted as that of dual venue; however there may be issue with the fact that BAC would want to have a three days meet but the other club could not get pool time for three days;
- e. Meet schedule will be sent out by July 24, voting will be due by July 31;
- f. Skeleton schedule has been approved: five dual venues in total, zone meets scheduled no closer than every other week. Schedule will be sent out for bidding;
- g. Diana Cheung (SSF) requested a sanction, which allows for one session per day rather than two. Mike B. (Sanctions Chair) said that one session is fine, as long as it follows the 4 hour time limit. Marcus N. suggested we have 10 instead of 8 lanes.
