The 2019 Coach Education Grant

In an effort to support our member clubs and to provide direct impact to our athletes, the Pacific Swimming Board of Directors offers the third grant in the quad series. The Coach Education Grant funds awarded will be based on the number of year-round athletes (see below), and will be allocated for the purpose of purchasing any product or service that will have a direct impact on coach education and development, which will ultimately benefit the athletes of Pacific Swimming.

Grant Overview (all)

Pacific Swimming will fund the following grants in sequence (below) through the first three years of each quad, with no grant for the Olympic year due to the additional funds needed for the Olympic Trials. The committee *will* evaluate possible grant options during that year given the budget and the state of the investment portfolio. The Grants, with examples, will be as follows:

Club requirements for Equipment Grant:

- Must be in good standing with Pacific Swimming, i.e., no outstanding obligations and current on registrations
- Clubs must be represented at the October or the *previous* May House of Delegates meeting
- Clubs must have working officials at a minimum of:
 - One official for clubs under 100 members
 - Three officials for clubs from 101 members to 200 members

- Five officials for clubs over 200 members

Note: a “working official” is one who has worked at least ten sessions per year and must be attached to the club during the qualification period of September 1, 2017, to August 31, 2018.

Grant awards will be as follows:

- Clubs between 20 and 100 year-round members will receive \$1,250
- Clubs from 101 to 200 year-round members will receive \$1,500
- Clubs over 200 year-round members will receive \$2,000
- We will recognize multi-site clubs (with over 150 athletes per site)

Note: clubs must have at least 25 year-round, attached athletes, and cannot be collegiate clubs.

Reminder of Ongoing Support from Pacific Swimming

In addition to the Grant Program outlined above, as a part of the Club Development/Coach Education Program, Pacific Swimming will continue to provide free access to all on-line video and audio content in the ASCA library (to ASCA members – coupon code is **pacificfree**), as well as a CD copy from the ASCA World Clinic with PDF's of all presentations. Additionally, the USA Swimming Mentor Program will run on an ongoing basis, but will be limited in scope to a predetermined budget, and on a first-come, first-served basis (see **Mentor** information on the website). Pacific Swimming will also continue to offer a comprehensive seminar by Russell Mark of USA Swimming every other year. In summary, ongoing support from Pacific Swimming includes:

- *Free unlimited access to ASCA's on-line library and coursework (video and audio)*
- *World Clinic CD (PDF's of all presentations)*
- *ASCA membership to new coaches (first year only)*
- *Russell Mark (USA Swimming High Performance Consultant) Seminar – every other year (next in 2019)*
- *USA Swimming/Pacific Swimming Coach Mentor Support (in conjunction with USA Swimming)*
- *Also, Pacific Swimming Club Development is building a “library” of supporting documents to help clubs and coaches.
