    - iii. Still in need of an Athlete Guest Speaker, multiple people reaching out to contacts
    - iv. Leland Brown III is attending from USAS to speak at both camp and summit
    - v. Oakley will be attending to speak at both as well
    - vi. 3 coaches from PC and 3 from SN
  - d. On-Line Outreach meet entry – Developing a feature on FastSwims so that Outreach registered athletes can enter meets online and still pay only the splash fee.
    - i. FastSwims is working to come up with an estimate on the cost to develop the feature
