Safe Sport	 Marisa Cozort: Gather more data from USAS on the number of clubs in the process of being Safe Sport Certified. Only 25% of teams in Pacific Swimming have completed the Safe Sport Club Recognition program. Have been reaching out to teams (43 so far) to help them get the process started. USAS definition of Safe Sport: Program allows member clubs to demonstrate its commitment to creating a healthy and positive environment free from abuse for all its members, through the development and implementation of club governance measures, safe sport policies and reporting mechanisms, safe sport best practices and training to athletes and parents. 20 teams have started the process Goal by the end of the year to be at 50% of teams completed, which will put PC in the top 8. Suggestion for teams to only be eligible for grants if they are Safe Sport Recognized.

	Amendment to the Policies and Procedures to clarify the 4-hour rule for 12 & under athletes. SECTION X MEET CONDUCT A. Meet Conduct 1. There shall be no limit on the number of events offered at a meet. 2. In Pacific Swimming Zone awarded meets, 15 and over events are allowed. The Zones shall determine applicable time standards and awards for 19 and over athletes. 3. Open events (events not limited to specific ages) beginning or concluding a session, or scheduled in a separate session, within an age group meet shall not be considered age group competition, and shall not be subject to the 4-hour session planning limit for 12 and under competitors.
