New Business	<p>Payroll Protection Plan Under the CARES Act/SBA Loan - Mary Ruddell</p> <p>Mary Ruddell and Cindy Rowland have been in touch with Chase, our banker, our auditor and our accountant, and webinars to examine this program and the requirements:</p> <ol style="list-style-type: none"> 1. Employers must keep all their employees and/or rehire them by June 30th if they have been let go 2. They must apply for the loan with the bank they do business with - ours is Chase 3. This is for non-profits and 75% of the loan must be used on payrolls over the 8 weeks after the funding date for the principal of the loan to be forgiven (not the interest on the loan) 4. The loan will be 2.5 x the average monthly payroll (ours is \$22,000 to \$23,000 per month so we would be applying for approximately \$55,000) 5. No required payments on the loan are expected for the first 6 months, and Chase is expecting the interest to be approximately 4%, with a 10 year payment plan 6. We need to show our business is impacted - we have no revenue coming in but still have payroll, office rental (\$1377), utilities, rental of storage space (\$450/month), staff phones (\$158/month), conference calls (varies depending on use). We pay Go to Meeting annually which we already paid (\$468/year) but we needed to pay an additional \$120 in order to increase the number of participants so we can have 	Mary will apply for the PPP Under the Care Act as soon as Chase puts the application on-line	

	<p>meetings like this one. In normal circumstances we would have been bringing in over the 3 months, a revenue of about \$80,000.</p> <p>We are well placed to get one of the loans relatively quickly, hopefully within 4-5 weeks (while many of our clubs will have a harder time getting through the process. We encourage all our clubs to apply as nonprofit small businesses and we will try to tutor the clubs in how to apply to their banks).</p> <p>Getting that money will free up more of our reserves to be used to help those clubs in our LSC who are in extreme financial difficulty caused by the pandemic.</p> <p>Motion passed to allow Mary Ruddell to apply for Pacific, as soon as it opens (Motion 2003MR 01 Approval to apply for PPP Under the CARES Act/SBA Loan). 	<p>Club Assessment Surveys - Cindy Rowland</p> <p>She received 68 responses of around 120 some clubs</p> <ol style="list-style-type: none"> 1. About 22 clubs have 3 months of reserve, 16 with 2 months reserve, 1 with 1 month reserve. Several clubs are shut down and will pick up when this is over. Some are significantly impacted and some we have been unable to contact. 2. Requests for relief vary from help with paying coaches, being relieved of paying Pacific's portion when they run meets in the near future 3. There are some teams where the survey bounced back and there is a need to figure out how to reach them <p>It was decided that the information from this survey needs to go to all the Zone Chairs, along with the list of clubs that have not responded, so they can follow up and figure out what the Zones can do to help their clubs before accessing Pacific Funds.</p> <p>Veronica suggest the information be placed on an excel spread sheet so it can be arranged in appropriate categories so we can begin to figure out priorities, and specific ways of providing support.</p> <p>Cindy will make sure all the Zone Chairs, the Vice Chair of Operations and the General Chair will have the information from the Survey.</p>	<p>Cindy Rowland will put survey information on an excel spread sheet and disseminate it to Zone Chairs and Vice Chair Operations, Vice Chair Development and General Chair</p> <p>Zone Chairs will follow up with the Teams in their Zone that have not responded yet.</p>	
	<p>Town Hall Meetings - David Cottam</p> <p>At the Mighty Mega LSC Conference call it was suggested as both helpful and morale building to have Town Hall Meetings where Coaches and other members of USA Swimming can share information and support each other.</p> <ol style="list-style-type: none"> 1. If possible, Mary Ruddell will try to be present at the first Town Hall Meeting for each Zone to give a tutorial on how to apply for PPP under the CARES Act. We will try to video tape her first presentation and then have it posted on the website so Coaches and Teams can access it as they need it. 3. Each Zone will try to garner what the most Frequently Asked Questions will be and we will post that on the website as well. 4. Debbi Tucker indicates, she and Kevin Twohey are pretty swamped by their regular jobs in hospital and emergency and will have difficulty setting up a Town Hall 5. It was agreed that Zone 3 and Zone 4 can combine to have a Town Hall Meeting. 	Teams and Coaches regarding PPP under CARES Act	
	<p>Might Mega LSC Conference Call - Leo Lin</p> <ol style="list-style-type: none"> 1. There was discussion in this conference call suggesting that LSCs give the LSC money which they plan to use to aid their teams, to the USA Foundation, allowing the Foundation to determine the distribution in order to provide equitable distribution and eliminate bias regarding conflicts of interest within the LSC. This was not supported by this Executive Committee. Comments included: this would be too cumbersome, concern about what would happen to the money, the LSC knows their teams better so they could provide the most effective use of the limited funds, and agreement that the LSC had sufficient maturity and objectivity to set priorities and distribution appropriately, even if this meant not being able to get matching funds from USA-Swimming. 2. USA Swimming has decided they will begin sanctioning USA Sanctioned Meets, (such as Sectionals, Grand Prixs, Junior and Senior National) only when the whole country would be open and able to have meets. We in the LSC, will determine when it is appropriate to open LSC and Zone meets and what types, in order to adjust to the circumstances (dual meets to limit the number of swimmers at a meet, etc.) 3. Town Halls are really a boost to morale, especially for Coaches. We have addressed that. Veronica states that Coaches have set up an internet happy hour on Saturday night where everyone to share ideas, how they are and everyone will BYO (alcohol). 4. Reinforce MAAP ratio of 1 Coach/Adult to 8 swimmers. The MAAP rules are posted on our website, and those regulations should be followed in all activities, including the innovative ones being created to handle the present situation.
