## 14. New Business

- a. **Zone All-star Developmental Meet**, Sunday March 7, 2010, Zone 1S, Morgan Hill CA.
  - i. Louise Marin (TAHO) will be Team Manager again this year, unless someone else would like to do it! Volunteers always welcome!
  - ii. **Coaches needed!** Some uncertainty about conflict with first High School meets.
  - iii. Draft Letter of Intent – modify & approve language, co-pay amount. (**Action Item**)
  - iv. Approve reimbursement of Team Manager, and up to 6(?) chaperones, \$21 each for USA Swimming background checks. (**Action Item**)
  - v. Decide compensation level(s) for Head Coach/entries coordinator, other coaches. (**Action Item**)
  - vi. Selection criteria and process – any changes needed from last year? (**Action Item**)  
*For each age-group and gender (based on age as of March 7, 2010), score best times 11-8-5-3-2-1-0 in each applicable event, 8th swimmer selected by the coach, ties broken using 100 freestyle time.*
  - vii. Pacific Swimming recommends formally selecting and ranking alternates in case of last-minute (pre-departure) illness, injury, or withdrawal. Alternates would be called in same rank order before or after entries are submitted (if after entries, might not have highest score in replaced swimmer's events). (**Action Item**)
- b. **Ratify appointment** of Albert Reed (CARS) as Alternate Athlete Representative to the Pacific Swimming Zone-4 Board of Directors. (**Action Item**)
