- a. **USA Swimming has issued new anti-bullying and electronic communications policies. All teams** must either come up with their own policy, or by default the USA Swimming policy will become the team's policy also.
- b. **New USA Swimming language on Deck Changing:** *"Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged."* **Meet Hosts and LSCs** have the option to replace the last 2 words with *"prohibited."*
- c. **Nevada State Championships** will be conducted at Desert Breeze Pool (Sandpipers) in Las Vegas Thursday afternoon through Sunday, February 21-24, 2013. Thursday warm-ups 1:00 pm.

- b. Among Pacific Swimming's accomplishments in 2011-2012, we sent 8 Athletes/Coaches to the Olympics, and had the largest number of Scholastic All Americans of all LSCs – 82.
- c. Pacific Swimming is submitting a Bylaws exception to USA Swimming requesting waiver of the term limits for the Pacific General Chair (John Bitter) for another 2 years so he can complete many of his initiatives that are still in progress.
- d. The Pacific Governance Committee is in the process of downsizing the Pacific Swimming Board of Directors, adjusting composition of the Executive Committee to include Zone chairs, and better defining the areas of Zone autonomy and responsibility.

### 13. Old Business and Action Items:

- a. **2013 Zone All-star meet** to be hosted by ZONE-4 at the Carson City facility 1<sup>st</sup> weekend in March. Carson facility reserved Saturday afternoon and Sunday, arrangements for timing platform still pending. Volunteers needed from ALL ZONE-4 TEAMS to staff the meet. Meet is a simple, single-session, 5-hour, pre-seeded meet (no check-in or scratches).

- b. **Zone-4 Budget:** continue discussion of ideas for cutting expenses and/or boosting income.

**Proposal (Action Item):** request that Pacific Swimming approve a 10-cent per event surcharge on meet entry fees for Zone-4 meets, to support Zone-4 All-star team coaches, Zone-4 Athlete co-pays for Pacific All-star teams, and Zone-4 officials recruiting, training, and retention. Entry fee for Zone-4 meets would become \$2.85 per event instead of \$2.75, with \$0.10 going to the Zone treasury. Currently Zone 1S has a similar athlete support program, and two other zones support athlete co-pays on a financial need basis. Have not heard from Zone 3.

- c. **Clarification of eligibility for the 800/1000 and 1500/1650 events in Zone-4 meets:** can the requirement for an official time in the 400/500 freestyle be satisfied earlier in the **same meet**?

a. **2013 Zone-4 All-star Team:**

- **ATHLETES NEEDED! - ALL Coaches please start identifying and encouraging eligible swimmers for the Zone 4 All-star team.** Swimmers must have at least 3 Pacific-A times in ANY events (in their age as of 3/3/13), and are NOT eligible if they have participated in Pacific Coast All-stars, Western Zone Championships, or North American Challenge Cup.
- **Proposal:** Allow 2012 OR 2013 Pacific-A times for eligibility (**Action Item**).
- **Applications** will be available shortly, will likely be due by late January, making January meet the last chance for times.
