Dear Joe,

It is unclear how program summaries and evaluations are presented to the Zone Chairman after the implementation of the program or project. But, it appears based on the recent experiences of several coaches on the Developmental All Star team that their recommendations have not been passed on, discussed, or heard at any relevant level.

We would like our views to be heard. The following is a summary which the coaches developed during our return from Carson City.

Positives:

- •We had Team sweat shirts, with matching caps, bag tags, and parka patches this year, which were ordered by our 11-12 coach.
- •The meet was held at a quality venue, which impressed many kids.
- •There was fun competition between swimmers, coaches, and zones.
- •Coaches from all zones were cooperative and friendly.
- •We had a faster, higher scoring team this year, which implies that we did a better job of recruiting and advertising for the meet. This, however, can still be significantly improved.
- After three years of placing last, we placed 4th, but realistically could have been 3rd if we had our 8 and Under team.
- •Group coaches held effective meetings with their groups, and quickly established a bond with their swimmers.
- •We had only one missed swim and only one DQ (13-14 girls B relay)
- •Bowling was a great bonding activity for the kids to have fun together. Not in place of a workout at the venue, but in addition to. Since there is still smoking in bowling alleys in Nevada we would recommend that in the future we do an activity in a non-smoking facility.
- •We received compliments from parents from other teams as well as our own, that our coaches and swimmers were very organized, on time, and united. They perceived the trip as being run very smoothly, despite some of our difficulties.

Issues to be discussed further:

- •We need to continue to promote this meet to make our team faster, and we need to get the application/ meet sheet out by September of 2008.
- •Budget for and try to set up dinner with all zones together in 2009.
- •We would like to make sure the 8 & Under team is included every meet, no matter where the meet is.
 - •They can be driven to the meet by parents and those parents will be allowed to stay at the hotel, given that the meet could be more than 2 hours away.
- •Revision of letter to parents and application
 - •Modeled after/copied exactly from WZ All-Star
 - •Parents not included in team activities, team meals, seating area at meet, and may not stay in the same hotel as athletes (except for the 8-under parents).
 - •Letter should include a list of acceptable/non-acceptable parent behavior

- •Increase communication between all staff members of the team.
- •Schedule a meeting of all of the staff members, before entries are due, to workout details, assign duties, establish a team cheer, and put together an effective line up. Have a tutorial on HyTek, if necessary. Coaches should benefit from the experience of this meet, as well as the kids.
 - •Team Management should not make any coaching decisions without consulting with the coaches.
 - •All positions on the team (team management, management assistants, head coach, individual group coaches) should all have job description and assigned tasks/duties to complete.
 - •Coaches should know have access to the information being given to swimmers and parents.
 - •Coaches should select the snacks, drinks, and meals that the kids will be receiving.
 - •Coaches should be included in the making of the itinerary and time lines for the whole weekend.
 - •We should establish a team cheer ahead of time, that all coaches have agreed on.
 - •We would like to have a team banner made, to be displayed above out team area
 - •Coaches should have and know a protocol for administration and safety situations
- •Create a certificate for the kids that participate and send it out after the meet along with the team picture, and a thank you letter.
- •Create a split sheet that all coaches can use, so we have previous data, and can properly record new information.
- •The venue should be scouted out ahead of time\. The trip route, designated stops, hotel, pool, and all other locations involved in the trip should be checked out, in person, in advance.
- •The room arrangements should be arranged for maximum supervision, and should be coordinated with any other zone that is staying at the same hotel.
- •Whoever is scouting out the hotel, should also find out if there are any other large activities going on in the hotel.
- •All coaches should receive a master roster with all important information of every swimmer on the team as well as coaching contact information.
- •We support the idea of having a formal evaluation immediately after each All Star meet to be reviewed, summarized, and presented at future Zone 1 South meetings.
- •If the Head Coach is not traveling on the main bus, someone should be notified about their Interim head coaching responsibilities. This includes procedures to contact the busing company if there are concerns about the bus driver, mode of transportation, or equipment.

Questions:

- •Is there a meeting between all of the zone team managers before the meet?
- •What are the responsibilities of the team managers. Are the team managers trained beforehand? Is there a team manager manual?
- •What are the responsibilities of the head coach?
- •How is the budget monitored? Reviewed? Established?

Goal for next year's head coach:

Answer and remedy all of the above concerns.

It is not our intention to point fingers or place blame on any specific individual. As coaches were are given a wide array of responsibilities for our own swimmers and our own teams. As All Star coaches our responsibilities are huge. In the past several years we have followed

our instincts blindly. Our intention is to have our concerns and questions answered. We feel that when this happens, our Zone, our coaches, and our swimmers will benefit.

PACIFIC SWIMMING ALL-STAR TEAM STAFF RESPONSIBILITIES

OBJECTIVE:

The objective of the Pacific Swimming All Star Team is to offer our swimmers a stepping-stone to the National Championships. In order to accomplish this, we must provide an environment that will provide safety and security to our team members and the experience and opportunity to compete against some of the best age-group swimmers in the country.

ROLES AND RESPONSIBILITIES:

AGE-GROUP VICE-CHAIRMAN (or designates):

- 1. As the elected representative of Pacific Swimming, responsible for the Staff and Athletes during the time of the All Star event.
- 2. With the Age Group Committee, establish and administer the selection process for selecting the swimmers.
- 3. Provide parents and staff with the information that they need to understand what will be happening during the event.
- 4. Based on the funds allocated by Pacific Swimming, will provide housing, meals, and transportation as required for the All Star event. And at the time of budget approval, present a staffing request to the Board of Directors that will be approved for the event.
- 5. Will coordinate and cooperate with the Head Coach and other staff to ensure that the Athletes have the greatest opportunity to compete at their best.
- 6. Ensure that everyone on the team has signed and complies with the Pacific Swimming Code of Conduct.
- 7. Shall enforce Pacific Swimming and All-Star Team policies and procedure.
- 8. Will maintain all forms on each swimmer including: medical release, code of conduct, swimmer information/letter of intent, etc.
- 9. Represent Pacific Swimming at All-Star Event Meetings.
- 10. Provide a follow-up report to Pacific Swimming on the results of the event.

HEAD COACH:

- 1. Approves the entries prepared by the Assistant Coaches.
- 2. Will represent Pacific Swimming at all meetings where a Coach Representative is requested.
- 3. Will supervise the Assistant Coaches.
- 4. Provide leadership and motivation for the team, so that they can achieve their own highest potential.
- 5. Create for each swimmer a sense of team spirit, so that they will strive to achieve their best for the team and help others to do the same.
- 6. Coordinate and cooperate with the Age Group Vice-Chairman and other staff to ensure that the Athletes have the greatest opportunity to compete at their best.
- 7. Along with all other staff members help to ensure that everyone complies with the Pacific Swimming Code of Conduct.
- 8. With the Assistant Coaches, establish the team rules that include the following: curfew, bed checks, team meetings, Coaches meetings, conduct during the meet and after the meet at the housing facility, team spirit activities, etc.
- 9. Foster team spirit and Good Sportsmanship by example and by planned Team Spirit activities, etc.
- 10. Notify the Age Group Vice-Chairman of any violations of the Code of Conduct or All-Star Team Rules.
- 11. Provide a report to the Age Group Vice-Chairman after the All-Star meet including: what went well, what problems occurred, and any recommendations for future events, etc.

ASSISTANT COACHES:

1. Prepare entries for their Group.

- 2. Take charge of their Group during the complete event, from the time the parents release their children until they are picked up again.
- 3. Work closely with Team Managers to ensure that the needs of the swimmers are being taken care of: plenty of fluids for drinking on the pool deck, etc.
- 4. Establish and communicate to your Group what will be expected of them during the swim meet, when they are swimming, when they are not swimming, and how they should act during meals and at the hotel or other housing facilities. Work with the assigned Team Manager to make sure that your rules and the Pacific Swimming Rules are followed. Enforce the curfew and other rules with bed checks and other activities.
- 5. Communicate with all your swimmers before and after each event, take splits, etc.
- 6. Notify the Head Coach and Team Manager assigned to your Group of any swimmer who is ill or injured.
- 7. With the Head Coach and other Assistant Coaches, establish and enforce the team rules that include the following: curfew, bed checks, team meetings, Coaches meetings, conduct during the meet and after the meet at the housing facility, team spirit activities, etc.
- 8. Foster team spirit and Good Sportsmanship by example and by planned Team Spirit activities, etc.
- 9. Notify the Head Coach of any rules violated by team members.

TEAM MANAGERS:

- 1. Assist the Age Group Vice-Chairman in setting up the housing, meals, and transportation for the event.
- 2. Work closely with the Coach of their assigned Group(s) to ensure that the swimmers are supervised at all times and that swimmer's needs are being met.
- 3. Ensure that one manager is in the team area at all times during the Swim Meet and that liquids are provided for the swimmers, and other snacks as required.
- 4. Assist in the enforcement of the Pacific Swimming Code of Conduct and All-Star team rules. Notify the Age Group Vice-Chairman and responsible Coach of any violations.
- 5. Notify the responsible Coach and Age Group Vice-Chairman of any swimmer illness or injury.
- 6. Provide a report to the Age Group Vice-Chairman after the All-Star meet including: what went well, what problems occurred, and any recommendations for future events, etc.
