Chairman's Report

January 8, 2014

- Speedo will be an official sponsor of the MAKO Far Western Short Course meet
- November 9th Diversity Camp held and for first time camp had a full roster of 50 swimmers need to brain storm how to get more coaches to promote the camp especially coaches from those teams that have been awarded diversity grants from Pacific
- Award meeting for LSC meets tentatively scheduled for February prior to the Pacific BOD meeting (for meets from Sept. 1, 2014 through Aug. 31, 2015)
- USA Swimming still intends to create a Zone Board of Review rather than relying on LSC Board of Reviews each LSC will provide 2 representatives to be available to sit on the Zone Board of Review. Governance Committee recommended that Pacific's two representatives should be appointed by the Executive Committee. Interested parties should send their credentials to the Executive Committee for consideration. USA Swimming will provide training and each Zone will pull from their pool of LSC representatives to staff each Zone BOR case. As a result it was felt that the Pacific representatives might be called upon sporadically and should have terms of at least 4 years. The Governance Committee will report their final recommendations regarding these positions after further deliberation.
- Pool Grant Program will continue for a fourth year, and it was determined that the penalty for a
 team not turning in the required end report regarding the use of the grant funds, is that they will
 not be able to host a swim meet until the report is turned in. This has proved to be an effective
 incentive, as teams that were delayed in turning in their reports are getting them in now that they
 know there is a penalty.
- Pool Grant Applications have been posted for this cycle. Teams that have never received funding
 from the Pool Grant Program will be given first priority. Return applicants are welcomed but will be
 given secondary priority, (Grant Application forms are posted in the "News" section of the website
 and on Facebook.)
- USA Swimming's Athlete Protection is working on creating an Incident Report form for non-injury incidents so that they can begin tracking athlete protection problems and alerting others
- Passed Motion 1311SR1 Sectional Support: approves pilot program to extend travel support to the Sectional level. \$40,000 is allocated to this program and it will end when the funds are exhausted and will be distributed on a first come, first served basis. This program will be evaluated at the end of the 2013-2014 season.
- Passed Motion 1311DC1 Diversity Grant Funds: approves grant funds to Carson Tigersharks, Presidio YMCA, Oakland Undercurrent, and Richmond Sailfish for a total of \$19,892.

- Pacific Swimming (PC) Web site Phase 2 planning/pricing presented at last PC board (BOD) meeting (have a copy of the handout of items and cost from PC BOD meeting – PC BOD decided not to pursue E-Commerce Store, Ticketing, and Social Feed items – pricing will be adjusted accordingly)
- OME project task force formed (Leo Lin, Mary Ruddell, John Bitter) will work in conjunction with USAS
- CSA League Review Task Force established to review and make recommendations regarding this
 pilot league
- New PC office job position defined plan is to hire someone this summer, train them, and have them ready for September
- People should read the Gunderson Report (not sure where it is on PC Web site) regarding recommendations for improving our Safe Sport Program and provide feedback about which recommendations to implement and which ones might be impractical.
- Lehla Irwin athletes are working on getting an athlete representative from each club
- There is one new club Soma Aquatics (SOMA)
- MSJA and EBAT will be "merging" Laurie Benton helping the two teams figure out the best approach since some approaches are far more bureaucratic and more expensive than others because of USAS requirements
- BOD approved name change of Boys and Girls Clubs of SF Starfish Aquatics (STAR) to San Francisco Swim Club (CITY)
- Jill will be producing a directory with clubs, zones, BOD officers, etc., similar to the USAS directory
- Western Zone Diversity Camp applications have been created and are ready for distribution PC will send 2 elite swimmers (must have at least a sectional cut), a coach, and a Diversity
 Representative contact is Kent Yoshiwara deadline will be sometime in April
- Approved Motion 1402DB1 Learn to Swim to approve spending \$4500 budgeted for Disability on the Learn to Swim program at Santa Clara International Swim Center. Additional funding of \$5200 to cover full program will be presented as a motion to the Executive Committee by Pam Redding of the Disability Committee.
- Approved Motion 1402IC1 Pool Improvement Grants for a total of \$24,846 to 7 of the 8 clubs that applied

DISCUSSION:

The main differences over previous budgets include the reduction in AllStar co-pay reimbursements and the movement of the remaining Dolphin system to 2015

Cliff Reyda

For Western Zone AllStars and NACC meets in 2014 and for the Pacific Coast meet in 2015, reduce the co-pay reimbursement from 50 percent down to 25 percent.

DISCUSSION:

The Zone 1 South Policies & Procedures allow the treasurer to reduce the co-pay down to 25 percent with Board approval. We are looking at a \$14K deficit budget if we do business as usual. This would save us about \$4K and along with deferring the rest of the Dolphin system purchase (separate motion) would result in a manageable \$3.3K deficit budget.

Drivers include:

- Two years of reduced net income from our Champs meet
- Pacific raised the co-pay of swimmers from 30% to 50% which results in a 66% increase in our reimbursement (from 15% of cost to 25%)

Cliff Reyda

Defer purchase of the remaining Dolphin System to 2015 (mainly scoreboards).

DISCUSSION:

This moves \$6.7K of expenses into next year. Along with reduction of AllStar co-pay reimbursements, this would allow us to bring our budget down from an estimated \$14K deficit to a manageable \$3.3K deficit.

Drivers include:

- Two years of reduced net income from our Champs meet
- Pacific raised the co-pay of swimmers from 30% to 50% which results in a 66% increase in our reimbursement (from 15% of cost to 25%)

This also allows more time to develop software to handle some of Dolphin's deficiencies.

DISCUSSION:

Bill Cunningham has been storing two of our old, mechanical scoreboards that were replaced by the LED ones and would like to get rid of them. Chairman's Report May 14, 2014

- House of Delegates meeting held Saturday, May 3 at the Domain hotel in Sunnyvale.
- Vice Chair Program Operation, Leo Lin, reported on the LEAP program required by USA Swimming. Pacific needs to have 5 athletes on the BOD (because we have 24 voting members). The Governance Committee recommends that the Senior Athlete and 1 athlete from each of the 5 Zones in Pacific be voting members of the BOD.
- Sr. Committee, Don Heidary, will be purchasing educational tapes so that there will be on item given to each of the teams in the LSC. Clubs need to let Don know which video they would like by the end of June. Contact Don if you cannot find details at www.pacswim.org.
- Sr. Committee reminded membership that a Senior Travel Support program has been created to support athlete travel to Sectionals (\$40K has been allocated).
- Sr. Committee looking into the USA Swimming Mentoring program we can look into getting mentors for clubs and/or coaches. If interested in this please let Don know.
- Registration, Laurie Benton, reminded membership that if you lose your USAS membership card you can go directly to USA Swimming with Deck Pass and print out a new card on line.
- Diversity Committee, Kent Yoshiwara report presented by Veronica Hernandez, reminded membership of the USA Swimming Outreach program that charges only \$5 for registration if a swimmer's family meets the criteria for being in the outreach program. Also, the Fred Siegrist Scholarship Program is available to help diversity swimmers in need attend All Star programs.
- Diversity Committee Western Zone Camp planning is underway and will take place at Call State East Bay. Athletes from 10 of the 17 Western Zone LSCs will be attending. There are some LSCs that will not be sending any athletes so there will be some slots available for more Pacific Swimming athletes. Please let Veronica or Kent know if there are athletes who might qualify.
- Scheduling, George Cleveland, of 32 LSC meets up for bidding, 25 were awarded. Most of the meets not yet bid are Age Group Open meets.
- Investment Committee, Mary Ruddell, reported that the value of the Pacific Swimming portfolio is presently \$2.2 million. The portfolio is managed by Wells Fargo Investors under the oversight of the Investment Committee. About \$51,000 of this is Zone 2 money. Any zone can invest funds through the Pacific Swimming portfolio.
- Marketing & Promotion, Jill Ruppenstein, reported that phase 2 of the Web site as almost complete. Club logos can now be loaded on the Pacific Web site. If your club has a logo, please forward an electronic copy of it to Jill for use on the Pacific Web site.
- Motion 1403TR1A: Membership Registration Dues approved increase in registration dues as outlined in the motion.
 Dues will go up \$8 every 5 years with the option to reevaluate the need for a second increase prior to the 2020 membership year. USA Swimming is raising dues \$2/year for the next 10 years. Pacific is absorbing at least \$4 of this cost. Takes effect Sept. 2014.
- Motion 1403TR1B: Event Entry Fees increases various fees. This motion was amended by 1404TR1BAmend.
 Increases the Age Group event entry fee from \$2.75 to \$4.00. All Age Group meets that are on the regularly scheduled seasonal program for Pacific Swimming or the Zones' Schedules (those meets that are up for bid from Pacific Swimming and from the 5 Zones) shall use the standard fee schedule for event entry fees. Auxiliary meets (invitational, dual, tri, superleague, etc.) added to the schedule may choose the "flat fee" option or any other fee schedule they choose.
- Motion 1403TR1C: Investigate Establishing OME approved giving the OME investigation ad hoc committee permission to investigate and plan for the development and implementation of a Pacific owned OME system.
- Volunteer of the Year secret ballot held. Candidates were Mary Ruddell, Leo and Marie Lin, Fred Vogelgesang, Peggy Ramirez. Results will be announced at the United States Convention in September.
- Next Pacific BOD meeting will be on July 23, 2014 at the Courtyard San Ramon, 18090 San Ramon Valley Road, 7:30 PM. Next Executive Committee meeting will be on May 21, 2014 by telecon.
