**Review of Minutes:**

- ✓ Motion and approval for changing Zone Meetings from monthly to every odd month of the year, and keeping the day the same, ~~or~~ ON the second Tuesday of each meeting month, 7:15 pm.

**Announcements and Correspondence:**

- ✓ Recap of Carson Meet 11/11-11/12 (400+ swimmers); several incidents, none of which resulted in injury, of swimmers and parents slipping on deck were reported; discussion regarding staying with the 2-day format and balancing out the morning and afternoon sessions (eg., change age group split to make session more even in terms of numbers)

**LSC Report:**

- ✓ Review of changes in Pacific Swimming regarding time standards
- ✓ House of Delegates meeting is scheduled for November 29, to be held prior to the Board of Directors meeting.

**Coaches' Report:**

- ✓ Teams are preparing for the upcoming Nevada State Championship Meet, to be held Jan 12-15, 2007, in Carson City.
- ✓ Registration of athletes and coaches for 2007 is underway.

### **Officials' Report:**

- ✓ Van Fortier will host an officials' clinic on Sunday, December 10, at 3:00 pm, in Minden.
- ✓ A letter will be sent to Southern California Swimming requesting assistance with officiating at the 2007 Nevada State Championships in Carson City.
- ✓ In an effort to provide a safe and optimal environment for competition, deck set-up at State in Carson will include areas which will be roped off and designated for swimmers and timers only.

### **Safety Report:**

- ✓ Deck slips at the Carson Meet included 1 swimmer and 3 adults; roles and responsibilities of lifeguards at meets was discussed; plans for decreasing deck slips @ Carson were discussed (eg., carpets)

### **Sanctioning Report:**

- ✓ Nevada State Championships entry form is in its final stages of approval; entries will be available for submission on Swim Connection and also by mail.

### **Scheduling Report:**

- ✓ Review of the Meet Dates for 2007.
- ✓ Discussion regarding the DDST Meet on February 9-11, 2007 being used as a qualifier for the Zone All-Star Meet; the meet may include relays.

### **By-Law Changes:**

- ✓ Approved. Section III Paragraph C (Suggested Change: Move month of elections to July from June if we have meetings only in odd months)
  - Election of Officers:
    - Nominations shall be made in May and elections held in *July* (**Change from June**) every year.
    - Term of office shall commence on the first day of September.
    - Each nominee, if not present during nominations, must give his/her consent to serve, prior to the election.
    - A nominee will be elected by receiving a majority vote cast by the authorized voting members present at the *July* (**Change from June**) meeting.

- ✓ Approved. Section IV Paragraph C (Suggested Change: Delete incentives)
  - Attendance of team representatives shall be taken at each meeting and reported in the minutes of that meeting.
  - **(Delete the following):** *Incentive for meeting participation shall be as follows:*
    - *Teams represented at 0-3 meetings annually will pay the full \$100 for membership dues for the following year.*
    - *Teams represented at 4-6 meetings annually will pay the \$50 for membership dues for the following year.*
    - *Teams represented at 7-9 meetings annually will pay the \$25 for membership dues for the following year.*

**Old Business:**

- ✓ The feasibility of having a clinic with Aaron Peirsol or Jason Lezak for Zone 4 Swimmers was discussed.

**New Business:**

- ✓ Motion, conditional based on getting a team manager and at least 3 coaches (9-10, 11-12, and 13-14 age groups): To once again participate in the Zone All-Star Meet, which will be hosted by Zone 3 and held March 4, 2007 at Koret Center in San Francisco; DDST, Carson, and Lakeridge expressed interest in participating in the meet.
