Meeting 3/13/07

The meeting was called to order at 7:25 pm

Announcements and Correspondence:

- ✓ Upcoming Pacific Swimming Board of Directors Meetings; March 28, April 25, and May 23, 2007. Jerry and Valerie Rudd (TAHO) will attend the meeting of March 28th.
- ✓ A special thank you to Joe Stubnar (DDST) for his efforts in making the Zone All-Star Meet a reality for Zone 4 on March 4, 2007 at the Koret Pool in San Francisco.
- ✓ Zone All-Star Meet Report: While the swimmers of Zone 4 were reported to have had a rewarding experience, and the philosophy of the meet, that is “to teach swimmers, coaches, and parents the different parameters of an ‘All-Star Select’ team”, and the idea “that winning and swimming fast, though important, are not the primary objectives” was certainly a prevailing theme, the organization of the meet itself was called into question. It was noted that several parent chaperones for the Zone 4 All-Star team were recruited as marshals for the meet, which subsequently pulled them away from their primary responsibility of chaperoning the team. Additionally, it was announced at the meet that there would be a closed deck, but the pool complex was apparently open for use by the public, and with this, potential questions of safety and security of young athletes was also questioned. A special thank you extended to all parents and chaperones, especially Lorna Johnston, of the all-star team.

Financial Report:

- ✓ Motion/S/Carried. Approve expenditures of \$200 each to coaches of the Zone 4 All-Star Team, per the Pacific Swimming Guidelines for Zone

All-Star Development Meet, specifically, “Funds can be spent by the Zone as they see necessary...”

- ✓ A reminder to submit expense report to Pacific Swimming (Treasurer, Fred Vogelgesang) for reimbursement to Zone 4 for its participation in the Zone All-Star Meet on March 4, 2007.

Treasurer –

- ✓ Checks for Zone 4 All-Star Team coaches, in the amount of \$200 per coach will be sent from the Zone 4 Treasurer to the respective coaches' teams for disbursement to these coaches.
- ✓ Total assets, as of 3/5/07, are \$8,231.98 (\$5,753.24 + 2,478.74 CD).
- ✓ A reminder to all Zone 4 teams that per the approval of changes to the Zone 4 Bylaws in November, 2006, membership dues are \$100 and are due and payable to the Zone 4 Treasurer by January 1 of each calendar year. Coaches' Report:

- ✓ It was reported that a petition was signed by coaches at the recent Gold Sectional Championships in Long Beach regarding travel of Western Zone All-Star Team swimmers to Farmington, NM on the last day of Far Westerns. The concern was raised that swimmers who qualify for the team and choose to represent their clubs on the final day of competition at Far Westerns would not only incur additional expenses for travel on their own to Farmington (swimmer co-pay for WZ is over \$500), but also not receive any reduction in their co-pay and that this might be a deterrent for swimmers to apply for this year's Western Zone All-Star Team. Alternatives to participation in the WZ All-Star Meet, specifically the "North American Age Group Championships" tentatively scheduled by Southern California, were discussed as viable options.

Officials' Report:

Officials Chair:

- ✓ Recent efforts to increase the number of officials in Zone 4 have been successful. It was suggested that clinics continue to be offered at upcoming meets, potentially including Carson (5/25-5/28), DDST (7/28), and Bishop (6/22-6/24), as well as in the Reno area (eg., Lakeridge).

Safety Report:

Safety Chair:

- ✓ There were three accident reports submitted from the Nevada State Championships, including an incident involving a swimmer collapsing behind the blocks prior to an event, one deck slip, and one swimmer getting kicked by another during warm-up.

Sanctioning Report:

Sanctioning Chair:

- ✓ Sanctions for both TAHO meets (6/2-6/3 & 7/13-7/15) have been given, pending several minor corrections.
- ✓ CARS Memorial Day meet ready for submission soon.
- ✓ RENO will request that time trials of the 200 yd. Breast be permitted at their meet 3/17-3/18.

Scheduling Report:

- ✓ Zone 4 Championships. Discussion regarding such issues as the purpose of the meet, the format ('A' and 'B' divisions), relays, scoring of the meet, and so on were discussed in an effort to offer an exciting, quality

championship meet to Zone 4 Championship swimmers, who historically range in ability from approximately entry level to pre-Far Western competition.
