#### **Old Business and Action Items:**

- ✓ Officials: proposals, requirements, discussion, etc.
  - o Proposed amendment to Zone-4 Bylaws to add administrative details to minimum officials rule. Tabled.
    - November meeting will have a motion to eliminate current officials requirements/penalties pending further discussion and resolution.
    - In the meantime, Zone 4 will continue with its current 'request' for officials in its meet sheets.
    - In addition, it was suggested that the following be used under the discretion of the meet referee:
      - When the number of certified USA Swimming member officials working in a session does not equal or exceed the following minimum staffing requirements, and the session timeline (as planned) is estimated to be at least 90 minutes, the Meet Referee may impose a mandatory 15-minute break after each hour of the session, said breaks not to be included in the session timeline for planning purposes. Minimum staffing requirements (not including the Meet Referee and Chief Judge if during a prelims/finals meets):
        - o Short-course meet, per course: 2 referees, 2 additional starters, and 6 additional stroke & turn judges (total of at least 10), or
        - o Long-course meet, per course: 2 referees, 2 additional starters, and 8 additional stroke & turn judges (total of at least 12).
  - o Minimum Officials rule: discussion and/or motions regarding implementation for Nevada State Championships February 17-20, 2012. Tabled.
- ✓ Athlete-Representatives Kyle Scalise (NNA) and Cassandra Marin (TAHO) re-appointed for 2012, with a request for recommendations (asap) for one more representative and one alternate.

#### **New Business:**

✓ High Country League Championships: review of the 2011 meet, with a request for suggestions as to recommended changes for 2012.
