**Announcements and Correspondence:**

- ✓ In an effort to assist city in opening local pools for the summer season, Sierra Nevada Community Aquatics (SNCA) is coordinating Adopt-a-Pool activities from May 29-June 7 and is asking for community support with these efforts.
- ✓ Annual Aquafest (a community effort to raise money for a new aquatics facility in the city of Reno, hosted by Sierra Nevada Community Aquatics) is scheduled for Saturday, August 25<sup>th</sup>.

**Financial Report:**

- ✓ Current Balance (as of 4/30/12): \$8,324.65
- ✓ Motion: To transfer the Zone 4 Business Market Rate Savings Account (\$2,481.18) to the Basic Business Checking Account, and close the Savings Account. Passed.
- ✓ Discussion regarding income and expenses in Zone 4. Zone 4 is currently experiencing budgetary concern. Several ideas were discussed to address this issue, including increasing annual dues; decreasing expenses for Zone All-Stars (2012, \$896.07); whether or not to continue compensating coaches for All-Stars; adjusting support for swimmer co-pays to Pacific all-star meets (e.g., NACC, Western Zones, etc.); reducing expenses in general; adding surcharges (\$15) for Zone All-Stars.

- ✓ NACC: This summer Pacific Swimming will send a smaller team, hold its place in the meet, and evaluate its level of participation for next year.
- ✓ Both NACC and Western Zone applications are posted on pacswim.org and are due by May 29<sup>th</sup>.
- ✓ Pacific Swimming Pool Improvement Grants: 19 have been awarded, including at least one from Zone 4.
- ✓ Pacific Swimming Governance Committee: Jim currently represents Zone 4 on conference calls. Committee continues to refine Pacific Board structure, look into more effective ways of keeping Rules, Regulations, Policies, and Procedures up to date, etc.
