- ✓ USA Swimming has issued new anti-bullying and electronic communication policies. All teams must either come up with their own policies, or by default the USA Swimming policies will take effect.
- ✓ New USA Swimming language on Deck Changing: "Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged." Meet Hosts and LSC's have the option to replace the last 2 words with "prohibited."
- ✓ Nevada State Championships will be held at the Desert Breeze Pool (Sandpipers) in Las Vegas Thursday afternoon through Sunday, February 21-24, 2013. Thursday warm-ups 1:00 pm.

LSC Report:

- ✓ 2013 JO, Far Western, and PRT time standards still pending.
- ✓ Among Pacific Swimming's accomplishments in 2011-2012, we sent 8 Athletes/Coaches to the Olympics, and had the largest number of Scholastic All Americans of all LSCs – 82.
- ✓ Pacific Swimming is submitting a Bylaws exception to USA Swimming requesting waiver of the term limits for the Pacific General Chair (John Bitter) for another 2 years so he can complete many of his initiatives that are still in progress.
- ✓ The Pacific Governance Committee is in the process of downsizing the Pacific Swimming Board of Directors, adjusting the composition of the Executive Committee to include Zone chairs, and more clearly defining the areas of Zone autonomy and responsibility.

✓ Basic and Advanced clinics conducted November 3 and 4, and planned again for December 4 and 5.

Safety Report:

✓ In an effort to insure safety at their meet venue, the Carson Tigersharks have implemented the use of a handout for meet marshals (Meet Marshal's Guidelines, adapted from USA Swimming). The handout briefly describes procedures for providing both a safe environment as well as what to do in the event of an emergency. With this, it is hoped that the role of meet marshals is both clarified and bolstered.

- ✓ Zone-4 Budget: continued discussion of ideas for cutting expenses and/or boosting income.
 - Action Item: request that Pacific Swimming approve a 10-cent per event surcharge on meet entry fees for Zone 4 meets, to support Zone 4 All-star team coaches, Zone 4 Athlete *co-pays for Pacific All-star teams, and Zone 4 officials recruiting, training, and retention. Entry fee for Zone-4 meets would become \$2.85 per event instead of \$2.75, with \$0.10 going to the Zone treasury. Approved.
 - *Currently Zone 1S has a similar athlete support program, and two other zones support athlete co-pays on a financial need basis. Have not heard from Zone 3
- ✓ Clarification of eligibility for the 800/1000 and 1500/1650 events in Zone-4 meets: In order for a swimmer to enter the 800/1000 or 1500/1650, he or she must first have a current time in a 400/500 free.
