- Applications due January 27th (prefer to receive by the Very Last Chance Meet, January 20). Plenty of openings for athletes to apply remain. Eligibility: Swimmers must have at least three 2012 (available in HyTek format from Zone Chair) or 2013 Pacific A times in any events (for their age group as of 3/3/13). Swimmers who have participated in Pacific Coast All-Stars, Western Zone Championships, or North American Challenge Cup are NOT eligible.
- 8 & Unders will receive all team gear and participate in team dinner & breakfast; however, they will not stay overnight at the hotel.
- Selection: January 28.
- ✓ Zone 4 Budget: the proposed \$0.10 entry fee surcharge has been submitted to the Pacific Swimming Executive Committee for review.

New Business:

✓ For discussion at March meeting: In line with a growing trend, running all events fastest to slowest in Zone 4 meets. Advantages: 1) Traditionally, early heats are more likely to have open lanes. Running fast to slow would better facilitate the use of these potentially open lanes for last-minute changes (e.g., administrative error, etc.); 2) Elimination of time conflict with distance events. 3) Faster swimmers finish earlier, allowing for more rest in trials/finals meets; 4) More experienced swimmers start first, thereby modeling proper competitive behavior (e.g., being to the blocks on time, fly-over starts, etc.) for less experienced swimmers.
