**LSC Report:**

- ✓ LSC Board proposal to require swimmers to have a short course PC 'B' time or better to enter the equivalent long course event. NT and coach verified times would not be acceptable for long course meets. This proposal is currently under review by Zones (e.g., does this proposal meet the needs of swimmers, coaches, and zones?).
  - Zone 4 Response: This is a nonissue for Zone 4 at this time. It is not uncommon for a swimmer to compete for the first time during the long course season; his or her participation, even with no time or a coach verified time, presents no difficulty.
- ✓ Conference call regarding budget and procedures for the 2014 Zone All-Star Meet (March 2, Burlingame High School).
  - Zone 4: 8 & under parents in charge of their swimmers for travel, but not at the meet, as this is an important time for young swimmers to learn about being with their team and all-star coaches.
- ✓ Congratulations to CARS on receiving a Pacific Swimming Pool Improvement Grant.
- ✓ Zone 4 still needs a new Senior Committee representative to the LSC. Volunteers? Steve Panzram (CARS) answers the call.
