# **LSC Report:**

- ✓ Kat Matheson (DDST-Zone 4 Senior Committee representative) distributed the proposed revisions (Sr 2/15-16 AA & Sr Circuit/17-18 AAA) to the Pacific Swimming Senior Time Standards, aimed at better meeting the needs of the Senior Program of Pacific Swimming.
- ✓ Revision to Pacific Swimming's scratch/no-show rules passed in November. Change pertains specifically to LSC age group championship meets (e.g., JO's, Far Westerns): No-show in prelims or timed finals, miss next prelim or timed-final event; No-show in finals, miss remaining finals events that day (this does not include relays), or first prelim event the following day.
  - Senior meets use National Scratch Rules, while Pacific Zone meets will continue to have no penalty for no-shows in timed-final events. Zones determine the system to be used in zone scheduled meets.
  - Question pertaining to the scratch rules for the upcoming CARS Blizzard Blast Meet (one day of prelims/finals). Jim Morefield to follow up with Brian Malick regarding how to proceed.
- ✓ CARS was awarded a Pacific Swimming Diversity Grant, which will provide scholarships to 9 athletes.
- ✓ In an effort to extend overall travel support, Pacific Swimming is now providing athlete travel support for Sectional meets, with funds being distributed on a first-come-first-serve basis.
