LSC Report:

- ✓ Question to all zones regarding USA Swimming registration fee increase of \$2/yr for the next 10 years. Might it be advisable to raise fees by \$5 now, then hold for several years (possibly even building programs that could impact the necessity for additional increases)? The potential difficulty with annual increases (e.g., changing forms, etc.) was discussed and weighed against a seemingly significant initial fee increase.
- ✓ Question about scratch/no-show rule for January Blizzard Blast meet was directed to Pacific Swimming Sanctions staff. Request for an amendment was submitted 3 days prior to the meet; however, neither an amendment nor response was received by the staff.
- ✓ A Pool Improvement Grant was awarded to RENO for Idlewild Pool.
- ✓ Applications now available (Pacific Swimming web site) for coaches and managers for the 2014 Western Zone and NACC All-Star Teams. Zone 4 coaches interested in participating are encouraged to apply.
- ✓ Pacific Swimming House of Delegates meeting schedule for Saturday, May 3, 2014. All Zone 4 teams are encouraged to send club representatives (be sure they are registered in advance).

Coaches' Report:

Officials' Report:

- ✓ A review of recent Zone 4 Officials Clinics reveals that 9 clinics have been held, with attendance from both Zone 4 and Sierra Nevada Swimming, ranging in topic from Basic Stroke & Turn to Administrative Referee.
- ✓ Currently in the works is the potential for a clinic for meet directors.
- ✓ The task of drafting a code of conduct for officials is being undertaken.

Safety Report:

✓ Blizzard Blast (CARS) there was an asthma attack; the recommendation to go to the local Emergency Room was declined.

Sanctioning Report:

✓ NNA (March) meet is sanctioned; CARS (May) meet is in the process.

✓ Zone-4 web site on Pacific Swimming is up and running – suggestions for content welcome.

New Business:

- ✓ Discussion of session format (and potential changes) for High Country Championships Aug 8-10. Keep scoring to 16th place; keep single morning session; NT allowed for 25s only.
- ✓ **Motion**: Approval of meet fees for High Country Championships Aug 8-10 (\$5/\$16/\$9). **Approved**.
- ✓ It was decided that Northern Nevada teams would not keep a special score at Nevada State Championships.
- ✓ **Motion**: Reimburse RENO (\$250), DDST (\$250), and NNA (\$500) for Zone All-Star meet support (i.e., coaching staff). **Approved**.
- ✓ Review of Zone All-Star meet included a few logistical issues (travel, time to warm up, food at the banquet) as well as issues of behavior and conduct of Zone 4 athletes at the hotel, the overall experience, etc. Danielle Christenson (CARS) volunteered to be meet manager in 2015.
- ✓ Zone-4 policy regarding participation of 8 & unders in the Zone All-Star Meet. Consistent with its previous position (with exception made for when the all-star meet is hosted by Zone 4), it is the general feeling of teams in Zone 4 that 8 & unders are too young for all-star competition. Youngsters at this age do well to learn the basics, the fun, the structure, and the family aspects of swimming; all-star meets are 'too much too soon' for these young ones. There's plenty of time in an age group career for travel, all-star competition, and team scoring.
