Financial Report:

- ✓ Current Balance (as of 3/8/15): \$10,586.09
- ✓ 2015 Team dues (\$100 year-round / \$50 seasonal) are past due.

LSC Report:

- ✓ Board of Directors (reps. Rudds/Morefield) -- Proposal to re-instate USA membership requirement for Marshals. This was eliminated several years ago because it was too hard to get enough volunteers to get carded, especially after background checks and athlete protection came online. BUT, Marshals are often dealing directly with athletes, checking locker rooms, etc., and should NOT be the people who can't pass a background check.
 - Discussion: Having Marshals get carded and have background checks will continue to make it difficult to get volunteers and having them do so is not a guarantee or failsafe way of protecting our athletes.
- ✓ Open Water Committee (Erik Scalise): Erik continues to explore the possibility of bringing an age group / masters (additional) open water event to Donner Lake (possibly an approved, not sanctioned event).
- ✓ Governance Committee (rep. Jim Morefield) finalizing job description for paid office manager; redefinition of LSC Board of Review to exclude Code of Conduct and Sanctions matters now covered by the USA Western Zone Board of Review.

Coaches' Report:

Officials' Report:

- ✓ Several clinics so far in 2015 continue to draw new interest and participation in officiating.
- ✓ 3 additional clinics are taking shape for the coming months.
- ✓ 5 administrative officials to date.

Safety Report:

- ✓ Recent incident in Solano County, CA., and Sierra Nevada response
 - O Discussion: There was general consensus that additional programs, carding, and background checks, while important for safety and liability, do not guarantee freedom from all evils in society. Passing a background check, for example, is a safeguard, but it is not foolproof and may lead to a false sense of security. It is up to officials,

coaches, parents, and swimmers alike to look out for each other, be aware of their surroundings, and report suspicious activity. We might be overestimating what can be gained with new programs, carding, and background checks. Education and awareness are key.

Sanctioning Report:
