- ✓ Athlete application deadline for summer all-star meets is June 1. Western Zone Age Group Championships (14 & U) are in Kihei, Maui, Hawaii, August 4-9; North American Challenge Cup (18 & U) is in San Diego, CA, August 5-9. Prospective Zone 4 swimmers are encouraged to apply. Zone 4 athletes who qualify and compete are eligible for up to 50% assistance from Zone 4 with their co-pay.
- ✓ Special congratulations to all the Zone 4 High School Regionals qualifiers & champions, as well as Nevada State High School Championships qualifiers.
- ✓ New meet sanctioning deadline are now in effect. Reminder: Sanction application > 90 days prior to the meet; meet sheet to Head Referee 75 days; meet sheet to Pacific Sanctions 60 days. Clubs (including head coach) & officials doing January and February meets will need to be especially attentive to renewing their USA Swimming registrations by October 15 each year. One potential upside to these new deadlines might be improved meet attendance.
