SANCTION: Held under USA/Pacific Swimming Sanction No. **22-049**

USE OF AUDIO AND VISUAL: Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the Meet Referee. Use of any audio or visual recording devices, including but not limited to film and digital cameras, cell phones and tablets, and Google Glass is not permitted in changing areas, rest rooms or locker rooms. Violation of this recording prohibition may result in ejection from the swimming pool facility by the Meet Referee or his/her designee.

LOCATION: GEORGE F. HAINES INTERNATIONAL SWIM CENTER, 2625 PATRICIA DR, SANTA CLARA, CA 95051

DIRECTIONS: From Highway 101, exit south on Lawrence Expressway or Bowers Ave; turn left at Homestead Rd; turn left at Las Palmas Dr; proceed to Patricia Dr and turn left. —OR— Exit Highway 101 on San Tomas Expressway; turn right on Homestead Rd; turn right on Las Palmas Dr; Proceed to Patricia Dr and turn left. There is limited free parking in the parking lot and adjoining streets. No parking allowed in the library parking lot (you will be ticketed).

COURSE: SCY SESSION: OUTDOOR 25 YARD pool with up to two courses (up to 18 lanes) available for preliminary competition; a 10-lane course will be used for finals. An additional 6 lanes will be available for warm-up/cool down throughout the competition. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is 4'6" at the start end and 4'6" at the turn end. In accordance with Article 104.2.2C(4) the competition course has been certified. A copy of the certification is on file with USA Swimming.
LCM SESSION: OUTDOOR 50 METER pool with up to 9 lanes available for competition. The diving well will be available for warm-up/cool down throughout the competition. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is 4'6" at the start end and 4'6" at the turn end. In accordance with Article 104.2.2C(4) the competition course has been certified. A copy of the certification is on file with USA Swimming.

- TIME:** SESSION 1 (SCY): Competition begins at 8:30AM with warm-up from 7:00AM to 8:15AM
SESSION 2 (LCM): Competition will begin no earlier than one (1) hour after conclusion of Session 1; with 45 minutes of long course warm-up. Short course warm-up lanes will be available starting at 8:30AM.
- RULES:**
- Current USA and Pacific Swimming rules and warm-up procedures shall govern the meet. A copy of these procedures shall be posted at the Clerk-of-Course.
 - The local facilities guidelines, restrictions and interpretation of the local public health guidelines shall be followed at this meet.
 - All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
 - All events are timed finals.
 - All events shall swim fast to slow
 - Athletes may compete in a maximum of three (3) events per session and six (6) events per day.
 - All athletes 9th grade and older are eligible to participate.
 - Athletes will be asked to show school ID card and USA Swimming ID (DeckPass).
 - Athletes in 8th grade and lower are not eligible to participate. No refunds will be given.
 - If local conditions warrant it, the Meet Referee, with the concurrence of the Meet Director, may require a mandatory scratch down. Immediate cash refunds shall be made for any mandatory scratches.
 - All Coaches and Officials shall wear their USA Swimming membership cards in a visible manner.
- ATTENTION HIGH SCHOOL ATHLETES (February through May):** High School Athletes in season may need to be Unattached from this meet. It is the Athlete’s responsibility to be Unattached from this meet. Athletes can un-attach at the meet if necessary. This does not apply to Athletes swimming under the rules of the Nevada Interscholastic Activities Association (NIAA).
- UNACCOMPANIED ATHLETES:** Any USA Swimming Athlete-Member competing at the meet shall be accompanied by a USA Swimming Member-Coach for the purposes of Athlete supervision during warm-up, competition and warm-down. If a Coach-Member of the Athlete’s USA Swimming Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the Athlete or the Athlete’s legal guardian to arrange for supervision by a USA Swimming Member-Coach. The Meet Director or Meet Referee may assist the Athlete in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the Athlete’s USA Swimming Club Member-Coach.
- RACING STARTS:** Athletes shall be certified by a USA Swimming member-coach as being proficient in performing a racing start, or shall start the race in the water. It is the responsibility of the Athlete or the Athlete’s legal guardian to ensure compliance with this requirement.
- RESTRICTIONS:**
- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, on standing areas and in all areas used by Athletes, during the meet and during warm-up periods.
 - Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
 - No glass containers are allowed in the meet venue.
 - Only Athletes, Coaches, Officials, and Volunteers shall be allowed on the pool deck.
 - Deck Changes are prohibited.
 - Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or his/her designee may ask that these devices be stored safely away from the public or removed from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are exempt per applicable laws.
 - Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, Athlete/Coach areas, Spectator areas and open ceiling locker rooms) any time Athletes, Coaches, Officials and/or Spectators are present.
- ELIGIBILITY:**
- Athletes must be current members of USA Swimming and enter their name and registration number on their entries exactly as they are shown in their USA Swimming Registration. If this is not done, it may be difficult to match the Athlete with the registration and times database. The meet host will check all athlete registrations against the SWIMS database and if not found to be registered, the Meet Director may accept the registration at the meet (a \$10 surcharge shall be added to the regular registration fee). Duplicate registrations will be refunded by mail.
 - This walk-on meet is a post high school champs shave/taper meet; the meet is restricted to athletes who are in 9th grade and older. USA Swimming cards and Student IDs will be checked.

- Athletes with a disability are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding special accommodations.
- Entries with "NO TIME" will be accepted.
- Entries for each session will close when the estimated timeline reaches 3.5 hours.

ENTRY FEES:

Participation Fee	\$14.00
Online entry fees (per event)	\$7.00

*Entries will be rejected if payment not sent at time of request.

DECK ENTRIES: Athletes may enter the meet on deck prior to each session. Entry fees for deck entries are \$14.00 participation fee and \$10.00 per event. Make checks payable to Santa Clara Swim Club (SCSC).

SESSION 1: Deck entries for the first two events will close at 7:30am on Sunday; the next two events will close every 15 minutes thereafter.

SESSION 2: Deck entries for the first two events will close at one hour before the session starts; the next two events will close every 15 minutes thereafter.

CHECK-IN: The meet will be deck seeded. Athletes will check-in at the Clerk-of-Course. No event will be closed more than 30 minutes before the scheduled start of the session. Close of check-in for remaining events will be no more than 60 minutes before the estimated time of the start of the first heat of the event. Athletes who do not check-in will not be allowed to compete in the event.

SCRATCH RULE: Athletes entered in a timed final individual event that is seeded on the deck that have checked in for that event, must swim in the event unless they notify the clerk of the course before seeding for that event has begun that they wish to scratch. Failure to swim an event shall result in being barred from their next individual event.

ENTRY FEES: \$7.00 per individual event plus a \$14.00 per Athlete participation fee. Entries will be rejected if payment is not sent at time of request. No late entries will be accepted. No refunds will be made, except for mandatory scratch downs.

ONLINE ENTRIES: To enter online go to www.fastswims.com to receive an immediate entry confirmation. This method requires payment by credit card. FastSwims charges a processing fee for this service, 6.5% of the total Entry Fees plus \$0.75 per transaction, regardless of number of Athletes. Please note that the processing fee is a separate fee from the Entry Fees. If you do not wish to pay the processing fee, enter the meet using a mail entry. Entering online is a convenience, is completely voluntary, and is in no way required or expected of an Athlete by Pacific Swimming. Online entries will be accepted through Saturday, May 7, 2022.

DECK ENTRIES: Deck entries are \$10.00 per individual event plus the \$14 participation fee. Make checks payable to Santa Clara Swim Club (SCSC).

SESSION 1: In order to compete in session 1, athletes must either (1) enter online by 8:59pm Friday, May 7, 2022 or (2) turn in their paper entries on the day of the meet (paper entries will be available at check in). The first two events will close at 7:30am on Sunday, and then the next two events will close every 20 minutes thereafter. Paper entries will be accepted until the event closes.

SESSION 2: In order to compete in session 2, athletes must either (1) enter online by 8:59pm Saturday, May 7, 2022 or (2) turn in their paper entries on the day of the meet (paper entries will be available at check in). The first two events will close one hour before session 2 starts (TBD), and then the next two events will close every 20 minutes thereafter. Paper entries will be accepted until the event closes.

ADMISSION: Free. A meet program will be posted at the pool and given to coaches and officials.
