Swimmers who are members of USA Swimming and have one or more qualifying standards in individual events may enter the meet beginning Friday, March 1, 2019 at 9:00 AM Pacific time through USA Swimming's OME system (usaswimming.org/ome) until the entry cap is reached.

The entry deadline is 11:59 pm Mountain Time on Tuesday, May 28, 2019 or as soon as the entry cap is reached. The qualification period is 24 months prior to the entry deadline. Entries are not accepted until they have been officially submitted in the OME system.

ELIGIBILITY This meet is open to all qualified swimmers. US swimmers must be registered as a year round member of USA-Swimming. Foreign swimmers must be a member recognized by their respective FINA Federations. Foreign teams/swimmers wishing to participate should contact Stellar Ezrre (sezrre@santaclaraswimclub.org) for the appropriate USA-S Invitation forms.

NOTICE By entering this meet, the athlete and his/her guardian consents to the publication, via electronic, print or other media, information and/or imagery related to their participation at this meet. Such information and imagery may include, but is not limited to, photographs, video, web casting, television, psych sheets, and live meet results.

RULES	<p>Unless otherwise noted herein, this meet shall be conducted in accordance with current USA Swimming Rules and Regulations. A Meet Committee consisting of at least one official, one coach, and one athlete will be appointed by the Meet Referee to review conflicts arising from administrative matters.</p> <p>There will be no on deck registration.</p> <p>Any U.S.A. swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</p> <p>During warm-up sessions, athletes must enter the water feet-first, except in designated lanes and times. Violations may result in disqualification from next individual event or expulsion from the meet. More detailed warm-up procedures will be distributed at registration and during the Technical Meeting.</p>
AUDIO & VISUAL	<p>Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the meet referee. Use of any audio or visual recording devices, including but not limited to film and digital cameras, cell phones and tablets, and Google Glasses is not permitted in changing areas, rest rooms, or locker rooms. Violation of this recording prohibition may result in ejection from the swimming pool facility by the Meet Referee or his designee.</p>
SCHEDULE	<p>Thursday: Timed finals for the 800 Freestyle events will begin at 5:00 pm.</p> <p>Fri-Sun Prelims: start at 9:00 am</p> <p>Finals: Start at 5:00 pm</p>
WARM UP	<p>Pool will be available for practice on Mon-Tuesday from 7:00 am – 10:30 am and 1:30 pm – 3:00 pm. Wednesday from 1:30- 4:00 pm. Thursday from 7:00 am – 10:30 am and 1:00pm to 4:45pm and for one hour after finals. On Friday to Sunday from 7:30 am till 1 hour after the conclusion of the prelims sessions, and from 4:00 pm until one hour after the conclusion of finals.</p>
TECHNICAL MEETING	<p>A technical meeting will be held at the pool at 3:00 pm Thursday. Details and information discussed at this meeting will be emailed to all coaches and posted on the Santa Clara Swim Club website immediately following the meeting. Coaches are responsible for all information presented and/or included in this posted information.</p>
FORMAT	<p>This meet will be conducted in LCM. 9 lanes for Preliminaries and 9 lanes for Finals. Timed Finals Events and Preliminary Heats of Individual Events will be seeded and swum FASTEST to SLOWEST. The top 27 (nine lane pool) swimmers from preliminaries will advance to finals. In the finals, the C heat will swim first, followed by the B heat, followed by the A heat.</p>

DISTANCE EVENTS	The 800m freestyle event will swim as Timed Finals. Positive check-in is required prior to the scratch deadlines in order to compete in the distance events. The 800m freestyle events will swim Thursday afternoon, fastest to slowest, alternating women and men beginning at 5:00 pm. Entries for the 800m event may be capped with the five fastest-seeded heats for each gender.
ENTRIES	<p>Any swimmer who has one or more qualifying standards in individual events may enter up to three bonus events. There are no bonus opportunities for events 400m or above. Each swimmer may participate in a maximum of ten individual events, with no more than three individual events per day. There will be no refunds once entries are accepted.</p> <p>The qualifying times for the 800m freestyle may be 800m, 1500m, 1000yd and 1650yd Freestyle. The qualifying times for 50m butterfly, 50m backstroke, and 50m breaststroke will be the corresponding 100m time or the 100yd time.</p> <p>All U.S. entries must be made online at usaswimming.org/ome no later than Tuesday, May 28, 2019 by 11:59 p.m. Mountain Time. The OME entry system will open March 1, 2019. You will be required to pay for the online entries with a Visa, Mastercard, American Express or Discover.</p> <p>OME is not an eligibility report. It is the coach's responsibility to know for which events your athlete is qualified. You can modify your entry online by adding to the original entry. You may not delete an online entry once it has been submitted/paid for. Once you complete your online entry, you will be sent confirmations via e-mail. Please keep all of these and bring them with you to the meet (just in case).</p>
FOREIGN ENTRIES	<p>FOREIGN TEAM ENTRIES: Foreign teams may enter using the Hy-Tek entry file provided. Entry files are due no later than Tuesday, May 28, 2019 at 11:59 PM PST. Email the entry file to sezrre@santaclaraswimclub.org. Mail a hard copy of the Individual Meet Entry Report, along with the entry fee check to Stella Ezrre at Santa Clara Swim Club, 2625 Patricia Drive, Santa Clara, CA 95051. Hard copies and checks SHALL arrive no later than Tuesday, May 28, 2019 at 11:59 PM PST unless prior arrangements have been made. If using overnight priority mail, please use the above address for delivery and WAIVE THE "SIGNATURE REQUIRED FOR DELIVERY": Foreign swimmers who are members of USA Swimming may enter through the OME system.</p>
SEEDING	Except for distance freestyle, events shall be seeded in order of LCM, SCY, LCM Bonus, SCY Bonus. Seeding for distance freestyle events will be LCM, SCY, Alternate Distance LCM, Alternate Distance SCY, LCM Bonus, SCY Bonus, Alternate Distance Bonus LCM, Alternate Distance Bonus SCY.
RELAYS	There will be no relays at this competition.
TIME TRIALS	Time Trials will not be conducted at this event.
AWARDS	There will be no awards at this meet.

LATE ENTRIES:	<p>Late entries will be accepted via OME under late entries, until 11:59 PM, Saturday, June 1, 2019, and are subject to the late entry fees listed below: Late Entry Surcharge: \$50.00 surcharge per swimmer Late Entry Fees: \$30.00 per individual event, Meet Surcharge \$35.00 OME Surcharge \$5.00</p>								
SCRATCHES	<p>Scratch Procedures: The USA Swimming National Championship scratch procedure and no-show rules will be used at this meet. These rules are described in the current USA Swimming Rule 207.11.6 in the Current Rule Book.</p> <p>Scratches and positive check-in for Thursday's distance events are due to the Administrative Referee 15 minutes after conclusion of the technical meeting and may be submitted by email to Robert Broyles, 208-669-2818, deepspace@prodigy.net. All subsequent day's events scratches are due 30 minutes after the start of the previous evening's finals. A swimmer qualifying for a Finals session who fails to compete shall be barred from the remainder of the meet, unless excused by the Meet Referee.</p>								
CREDENTIALS	<p>Credentials for coaches, managers, and chaperones shall be issued to those persons listed on the submitted team entry through the OME. Managers and trainers must be included on the entry submission to receive a deck pass. Athletes entered in the meet will receive a deck pass as part of their entry fee. All others will be required to purchase individual tickets. All persons requesting a deck pass must be registered with USA Swimming.</p>								
HOTELS	<p>A list of hotels for the event will be posted on the SCSC website.</p>								
OFFICIALS' INFO	<p>An officials' meeting will be held one hour prior to each session at the pool. This meet has been designated as a National Qualifying Meet to all officials who wish to and are eligible to be evaluated for advancement or re-certification. Request for evaluation should be made to the meet referee by e-mail (lilin@pacswim.org), or when they first arrive at the meet and attend pre-session meetings. Please send in your application prior to the meet by e-mail. We may not be able to accommodate applications submitted at the meet due to resource limitations. Applications to officiate at this meet is available on the Santa Clara Swim Club website.</p>								
COURSE	<p>The George F. Haines International Aquatic Center consists of an outdoor 50 meter, 9 lane competition pool with two separate 25 yard warm up pools. Omega electronic timing system with touch pads and scoreboard will be used for this meet. The minimum water depth in accordance with Article 103.2.3 is 4 ½ ft at the start and 4 ½ ft. at the turn end. The competition course has been certified in accordance with Article 104.2.2C (4). The copy of such certification is on file with USA Swimming.</p>								

RESTRICTIONS

- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, on standing areas and in all areas used by athletes, during the meet and during warm-up periods.
- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No glass containers are allowed in the meet venue.
- Only athletes, coaches, officials, and volunteers will be allowed on the pool deck.
- Deck changes are prohibited.
- Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or his designee may ask that these devices be stored safely away from the public or removed from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are exempt per applicable laws.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
- No pets or animals allowed in venue except for service animals.
- No electric or propane heaters / containers or similar devices including gasoline powered generators, other than provided for meet operations, are allowed in any areas of the meet venue.
- Except for coaches' seating next to the pool no chairs, canopies, tents, or "camping" in the competition pool area. All athlete and spectator chairs, canopies, tents, or other set-ups shall be outside the competition pool gates and on the lawn only. SCSC and the City of Santa Clara are not responsible for your set up if you leave them overnight.
