Violation of this recording prohibition may result in ejection from the swimming pool facility by the Meet Referee or his/her designee.

LOCATION: Sunnyvale Swim Complex @ Fremont High School, 1283 Sunnyvale-Saratoga Ave., Sunnyvale, CA 94087 [LINK]
DIRECTIONS: From Highway 280, exit N. De Anza Blvd. (Sunnyvale-Saratoga Ave.), travel north on Sunnyvale-Saratoga Ave until it reaches Fremont Ave. The pool is between the school's main entrance and the football field. There are two parking lots. Parking lot in the front of Fremont High School is for meet officials and swim coaches ONLY. Participants should park in the student lot (with solar panels) on the west side of the school campus off Fremont Ave.

COURSE: 50-meter, 9 lane, outdoor, heated pool with up to 8 lanes available for competition. At least 1 lane will be available for warm-up/cool down throughout the competition. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is $13^{\prime} 0^{\prime \prime}$ at the start end and $4^{\prime} 0^{\prime \prime}$ at the turn end. The competition course has not been certified in accordance with 104.2.2C(4).

TIME: Saturday and Sunday are split into "AM" and "PM" sessions
AM Session: All 13 \& Over Athletes and 11-12 Girls. Warm-ups from 7:00-8:15 AM. Meet begins at 8:30 AM
PM Session: All 10 \& Under Athletes and 11-12 Boys. The afternoon session will begin one hour after the AM Session finishes but not before 1:00 PM. Warm-up begins immediately after AM Session finishes.

## RULES:

- Current USA and Pacific Swimming rules and warm-up procedures will govern the meet. A copy of these procedures will be posted at the Clerk-of-Course.
- The local facilities guidelines, restrictions and interpretation of the local public health guidelines shall be followed at this meet.
- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- All events are timed finals.
- All events will swim fast to slow.
- Athletes may register for as many individual events as they want but will be required to scratch down to a maximum of THREE (3) events per day of the meet.
- If local conditions warrant it, the Meet Referee, with the concurrence of the Meet Director, may require a mandatory scratch down. Immediate cash refunds will be made for any mandatory scratches.
- All coaches and deck officials must wear their USA Swimming membership cards in a visible manner.

UNACCOMPANIED ATHLETES: Any USA Swimming Athlete-Member competing at the meet must be accompanied by a USA Swimming Member-Coach for the purposes of Athlete supervision during warm-up, competition, and warm-down. If a Coach-Member of the Athlete's USA Swimming club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the Athlete or the Athlete's legal guardian to arrange for supervision by a USA Swimming Member-Coach. The Meet Director or Meet Referee may assist the Athlete in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the Athlete's USA Swimming Club Member-Coach.

RACING STARTS: Athletes must be certified by a USA-Swimming Member-Coach as being proficient in performing a racing start or must start the race in the water. It is the responsibility of the athlete or the athlete's legal guardian to ensure compliance with this requirement.

## RESTRICTIONS:

- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, on standing areas and in all areas used by athletes, during the meet and during warm-up period.
- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No glass containers are allowed in the meet venue.
- No propane heater is permitted except for snack bar/meet operations.
- All shelters must be properly secured.
- Deck changes are prohibited.
- Swim meet patrons must observe and adhere to all posted signs and comply with facility staff requests.
- Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or his/her designee may ask that these devices be stored safely away from the public or removed from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are exempt per applicable laws.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present.
- Coach tents ONLY on the pool deck, no personal tents allowed. Space outside of the pool is for personal tents.


## ELIGIBILITY:

- Athletes must be current members of USA Swimming and enter their name and registration number on the meet entry card as they are shown on their Registration Card. If this is not done, it may be difficult to match the athlete with the registration and times database. The meet host will check all athlete registrations against the SWIMS database and if not found to be registered, the Meet Director shall accept the registration at the meet (a $\$ 10$ surcharge will be added to the regular registration fee). Duplicate registrations will be refunded by mail.
- Entries with "NO TIME" will be ACCEPTED, with the exception of the 400 free and 400 IM where times are needed for proper seeding.
- Entry times submitted for this meet may be checked against a computer database and may be changed in accordance with Pacific Swimming Entry Time Verification Procedures.
- Athletes with a disability are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding any special accommodations on entry times and seeding per Pacific Swimming policy.
- The athlete's age will be the age of the athlete on the first day of the meet.
- Athletes from Zone 1N priority clubs (listed at the top of the meet sheet) are eligible to register. Athletes from Zone $1 \mathbf{N}$ clubs NOT from the priority club list are NOT eligible and should enter DACA's meet scheduled for June 18-19, 2022.
- Athletes from clubs outside of Pacific Swimming Zone 1 N are eligible to register after the priority deadline of June 8 , and if the estimated timeline still permits.

ENTRY FEES: Individual: $\$ 4.50$ per event plus an $\$ 14.00$ participation fee per athlete. Entries will be rejected if payment is not sent at time of request. No refunds will be made, except mandatory scratch downs.

ENTRY PRIORITY: Priority entry will be given to the following Zone 1 N clubs: ALTO, BAC, BCP, BGC, DCD, FOG, HDAC, MAV, MLKB, OSC, PPSC, PSL, SUNN, SSF, YEMB. Those entering online must do so by 11:59 PM, Wednesday, June 8, 2022 to receive priority acceptance to the meet. Swimmers from the Zone 1 N priority clubs submitting surface mail entries must be postmarked by Monday, June 6, 2022 to receive priority acceptance into the meet. Zone 1N Athletes from clubs other than the priority club list will NOT be allowed to enter this meet. After June 8, and if the estimated timeline still permits, the meet will be open to swimmers outside of the Zone 1 N priority clubs.

ONLINE ENTRIES: You may enter this meet online at FastSwims or by U.S. mail. To enter online go to https://fastswims.com/ to receive an immediate entry confirmation. This method requires creation of a free account and payment by credit card. FastSwims charges a processing fee for this service, $6.5 \%$ of the total Entry Fees plus $\$ 0.75$ per transaction, regardless of number of athletes. Please note that the processing fee is a separate fee from the Entry Fees. If you do not wish to pay the processing fee, enter the meet using a mail entry. Entering online is a convenience, is completely voluntary, and is in no way required or expected of an athlete by Pacific Swimming. Online entries will be accepted through Wednesday, June 15, 2022 at 11:59 PM. LATE ENTRIES WILL NOT BE ACCEPTED. NO REFUNDS.

MAILED OR HAND DELIVERED ENTRIES: Entries must be on the attached consolidated entry form. Forms must be filled out completely and printed clearly with the athlete's best times. Entries must be postmarked by midnight, Monday, June 13, 2022, or hand delivered by 6:30 PM Wednesday, June 15, 2022. NO LATE ENTRIES WILL BE ACCEPTED. Requests for confirmation of receipt of entries should include a self-addressed envelope.

CHECK-IN: The meet will be deck seeded. Athletes must check-in at the Clerk-of-Course. No event shall be closed more than 30 minutes before the scheduled start of the session. Close of check-in for remaining events shall be no more than 60 minutes before the estimated time of the start of the first heat of the event. Athletes who do not check-in will not be seeded in the event.

SCRATCHES: Any Athletes not reporting for or competing in an individual timed final event that they have checked in for/entered shall not be penalized.

AWARDS: Ribbons for $1^{\text {st }}-8^{\text {th }}$ place will be given to the age groups: 8/un, 9-10, 11-12. No awards will be given for 13 \& over Athletes. A-time medals will be given to athletes achieving a new A-time standard per the 2021-24 USA Swimming Motivational Time Standards (http://www.pacswim.org/swim-meet-times/standards), regardless of the place achieved in the event. All awards must be picked up at the end of the meet by a coach or club representative. Awards will not be mailed.
**IMPORTANT**
Awards MUST be picked up on the day of the meet by a team representative.
Awards will NOT be mailed unless a pre-paid envelope is provided.
ADMISSION: Free.
PROGRAM: PDF of the program will be made available to the coaches and on www.SUNN.org.
SNACK BAR \& HOSPITALITY: A snack bar will be available throughout the competition. Coaches and working deck officials will be provided a light breakfast and lunch. Hospitality will serve refreshments to timers and volunteers.

## MISCELLANEOUS:

- No overnight parking is allowed. Facilities will not be provided after meet hours.
- Disobeying parking signs may result in a citation and a fine.
- All participating clubs are expected to provide lane timers based on the number of athletes registered to swim each day and session. Coaches/clubs will be notified of club timing lane assignments the Monday prior to the meet.
