### 5. Announcements & Correspondence:

- a. Applications are being accepted until **5 pm Saturday December 7<sup>th</sup> for the 2020 Pacific Coast All Star meet**, being held in Hillsboro, OR, January 4-5, 2020. 32 athletes will be selected to compete (age groups 11-12 and 13-14). Co-pay is \$340, half of which is reimbursable by Zone 4. Visit pacswim.org for the application and details.
- b. **Pacific Swimming Office Holiday Schedule** should be posted shortly on pacswim.org. Be prepared to have athlete registrations and urgent meet sanctions submitted by middle of December.
- c. **Reminder: all Zone-4 elected officers and appointed chairs must be 2020 USA Swimming members in good standing by January 1st.**
- d. **Reminder: 2020 Team dues** (\$100 year-round; \$50 seasonal) become due on January 1<sup>st</sup> (send to Jerry Rudd, Zone 4 Treasurer, P.O. Box 9698, South Lake Tahoe, CA 96158-2698).
- e. **2020 Zone All-star meet (ZAM)** will be Feb 29-March 1 at the George Haines International Swim Center in Santa Clara, CA. Athlete and Coach applications will be available shortly and will be emailed to all teams. Athlete applications will also be available and accepted at the January 17-19 Carson Blizzard Blast meet.
  - i. Kelly Schott raised her hand to take on the role of Team Manager for the meet. Jorie will be available for help/advice if needed as outgoing manager.

## 8. Safe Sport:

- a. Progress with MAAPP implementation by clubs? Issues or questions? Every club needs to designate a Safe Sport Representative. 18+ athletes without up-to-date athlete protection training will not have their times recorded in SWIMS.
- b. Clubs can participate to get club recognition through the safe sport webpage. Different actions are worth different amounts of points. Kelly is working on communicating this plan to teams and parents.
- c. Each meet must have a locker room monitoring policy and plan.
  - i. It doesn't need to be specifically written in the meet sheet. But just needs to have a plan.
  - ii. Athlete rep felt like just having adults use locker rooms and bathrooms normally was more sufficient than having scheduled sweeps.
- d. Comments:
  - i. Coach Sharon is not on board with the new Safe Sport program. She feels like there's a lot of focus on rules and checking boxes, but it seems like the point of safe sport is being missed. What happens when children are left unattended in a locker room with no adults? How is a coach supposed to do a good job with athletes who are emotionally breaking down if a coach can't talk with them one on one or can't give them a much-needed hug? Coaches are being forced to be paranoid and having to go overboard on having healthy boundaries. There are times when a hug is not appropriate, and there are times when a hug is entirely appropriate. And we should be able to express healthy boundaries. We need to be teaching kids how to say no and how to have healthy relationships.
  - ii. JoAnn feels like there should be teaching and advocating for children, but instead we are putting the burden for behavior on the coaches and officials. Instead, we should be empowering children with tools for communication and relationships.
  - iii. The athletes felt that the safe sport policy should be totally re-written. The rules now mean that the swimmers are limited in what they can do with their friends and their coaches. It seems to be way too much.
  - iv. As a committee, table felt like the new rules are burdensome and problematic and that situations and common sense will eventually lead to a backlash and a revision of policy. For Zone 4, we will keep using the bathrooms in a normal manner – no restrictions on having coach/official specific bathrooms.
- e. LSC Safe Sport Committee (rep. Jodi Wright) – currently forming a committee with a rep from each zone.

## 9. LSC Reports:

- a. **Board of Directors** (reps. Rudds/Morefield) -- October HOD approved new bylaws, increased budget by about 18K, and added \$20K from investment income to travel support for Olympic Trials. Executive Committee meeting right after HOD voted to extend Pacific office lease for 1 year while studying other options. Sept. 18 BOD, new JO and FW time standards posted.
- b. **Diversity, Equity, & Inclusion Committee** (rep. D'Lisa Crain and Valerie Rudd) -- Have gone over grant applications for this half of the year. Votes will be made to determining whether/how much of the grants will be awarded. Discussions about how monthly dues for athletes are more problematic than being able to cover meet fees. Discussions from the committee about how to fund these athletes. Diversity camp just concluded last weekend. Kelly Schott discussed opportunities for disabled athletes to compete and attend camps and outreach – including getting classified and having disability specific meets on the track for Paralympic participation.
- c. **Athlete Committee** (reps. Aidan Pflieger, Justin LoPresto, Juliet Kahue, Amelia Brady, Carlos Torres) – Aidan attended the Convention, and there were 2 goals set for Pacswim: 2 zone reps from each zone participating and at least 1 rep from each team participating actively in Athlete rep meetings. Aidan also participated in the Rise Against Hunger service project following the HOD meeting in October. The project went well with 46 athletes attending and over 8000 bags of food packaged. The athlete committee is likely to hold the service project next year. The committee is working on changing from phone calls to video conference calls so that athletes can be fully present for the meetings. There will also be a leadership summit for Pacswim since USA Swimming will not do one in an Olympic year. It will be aimed more for the older athletes. The Committee has also made t-shirts, but there are some logistical concerns about how to get them up to Zone 4 – may be able to have some Zone 4 adults pick them up at the BOD meeting next week.. The plan is to wear them at local meets for more

visibility and more participation from local athletes. Zone 4 can arrange for a table to be set up at the Blizzard Blast next to the All-Star Meet table.

- d. **Open Water Committee** (rep. Erik Scalise) -- Beginning in 2020, Pacific swimming will implement a new general open water event meet sheet template. Pacific swimming may adjust the meet sheets further but it should be out soon. Officials will have a new online class to be an accredited open water swimming official. The NNA Donner Dip in August was asked to be the first newly sanctioned open water swimming event for Zone 4.
- e. **Senior Committee** (rep. Kat Matheson) – no recent activity.
- f. **Age Group Committee** (rep. Jim Morefield) -- consolation finals added to spring Far Westerns.
- g. **Governance Committee** (rep. Jim Morefield) -- Governance will be working on the task of implementing the new LSC bylaws through amendments to the LSC Rules & Regs and Policies & Procedures.
- h. **Finance & Investment Committees** (rep. Jerry Rudd) -- committee reviews LSC financial statements, reports, and accounting procedures on a monthly basis.
- i. **Scheduling Committee** (rep. Jo Ann Porter) -- long course JOs have been awarded to Quicksilver.

#### 10. Coaches Report:

- a. State meet went well from the swimming side. The logistics and communication from the South was abysmal.
- b. 2020 State meet will be in Carson next year. There will be discussions about which date to put the meet on since the Veteran's Day holiday will fall on a Wednesday. Coach Julie will be sending an email to teams in the state for feedback on dates, and relays, etc.

#### 11. Officials Report:

- a. Mega clinics coming up in December. Potentially add a Meet Director's clinic to the mega clinic if there's interest. December 15/16 at the school district offices near Meadowood Mall.
