**2. Announcements:**

- a. Carson Tigersharks have been recognized by Pacific Swimming on becoming a Safe Sport recognized club.
- b. Zone 4 Meetings upcoming – alternate dates for summer meeting (July) with later and/or alternate times and dates. Next meeting: July 12, 2020

**3. Team/Rep Updates:**

- a. DDST – back in the water for a week; after-hours times only; pool is empty; 90 minutes; short sessions for each group.
- b. LAKE – back in the water since June 6; max 3 per lane; great to be back; definitely a learning curve in terms of daily protocol (e.g., no spectators, physical distancing, etc.); easing back into training.
- c. NNA – Learning as we go; each day of the week has gotten better; difficult to predict about meets; we are held hostage by factors beyond our control
- d. Amelia Brady (NNA-AthRep) – a one-day meet sounds good, shorter distances
- e. RENO – It’s great to be back on the pool deck; really happy with the City of Reno getting the pool open; governor actually said 50% occupancy; we’d like to see numbers per lane go up, but we are also really thankful to be back in the water; end of September is the goal for keeping Idlewild open; Jim > expressed concern regarding what we face when the outdoor pools close in early fall
- f. Aiden Pflieger (RENO-AthRep) – re: meets; taking it slowly; National Diversity & Inclusion Committee conversation in recent meeting with athletes about racial injustice; Aiden Pflieger > elected to PC Athlete Junior rep and Carlos Torres to take over this position
- g. Andrea Sullivan – new sanctioning chair excited to get started when there is a meet to sanction; she will touch base with Shari Buonamici.
- h. Kendra Follett – Officials committee, what can we expect? No other meeting since previous; still determining number of timers; bare bones of officials; Jim > once meets are allowed again, sanctioning process could be short in terms of

being able to put things together fairly quickly; details of that are yet to be worked out; possibly a more relaxed fee structure (e.g., sanctioning fees) Kendra > questions about financial feasibility of holding meets

- j.** Veronica Harmon – no updates, but she is ready to be back in action as things are approved
