- a. Tigersharks Intermountain Classic
  - i. 1 swimmer slipped off blocks and cut their foot on the lane rope. Band aid administered. No follow up care needed.
  - ii. 1 official slipped on the stairs to the stage and rolled an ankle. No follow up care needed.

## 8. Safe Sport:

- a. LSC Safe Sport Committee report (rep. Veronica Harmon) –
  - i. MAAPP 2.0 has been released and will be implemented in September.
  - ii. There are a number of training sessions about the new changes to MAAPP available to swimmers, coaches, and parents. Most scheduled for 5pm on the west coast.
  - iii. Webinars will be posted following training sessions if you aren't able to make the scheduled time.
- b. New issues or questions:
  - i. The MAAPP training sessions are to learn the new changes. This is different than the APT training sessions that are required for membership and Safe Sport certifications.
  - ii. The new MAAPP 2.0 should be updated on team websites in documents, etc. Also, team membership and policies need to be reviewed and approved by parents and athletes in September for the upcoming year. However, teams will remain Safe Sport certified until they need to renew.

- a. **Updates on meets, practices, facilities, etc.**
  - i. CARS: Training basically back to normal with few covid restrictions. Will be hosting state champs.
  - ii. DDST: Carson Valley Swim Center mostly back to normal with covid protocols. Still doing temperature checks but not much else. Considering changing dates of High Country to make sure there is still good participation for all athletes – conflict with NNA meet and with Western Zones. Perhaps move high country to later in the summer. Kat will follow up with coaches.
  - iii. LAKE: Sharon had a great week at Olympic Trials. Pretty amazing to see athletes rising up given the challenges of the last year. Really neat to see the level of inspiration for all athletes – beginning of their national career and potentially end of career. Currently, Sharon feels very overwhelmed with amount of meets and planning for meets and expectations after the covid hiatus. Lots of nods from everyone on the call.
  - iv. NNA: getting ready to host everyone for Silver State Champs. About 350 swimmers signed up. Training going well and looking forward to the end of summer season.
  - v. RENO: Had a great experience at Trials. Good to see 3 teams from Zone 4 represented. They thanked all the participation at the Reno Gamble. Looking forward to the season ending meets at High Country, Western Zones, and Futures. Looking forward to a more normal fall schedule.
  - vi. TAHO: Back to almost normal practices. Still looking for more pool time with the Rec Center. There is a lot of interest in training and competing, with the outlook of the club good for the future. The Bubble will now be on the pool permanently until the new pool/rec center is completed.
