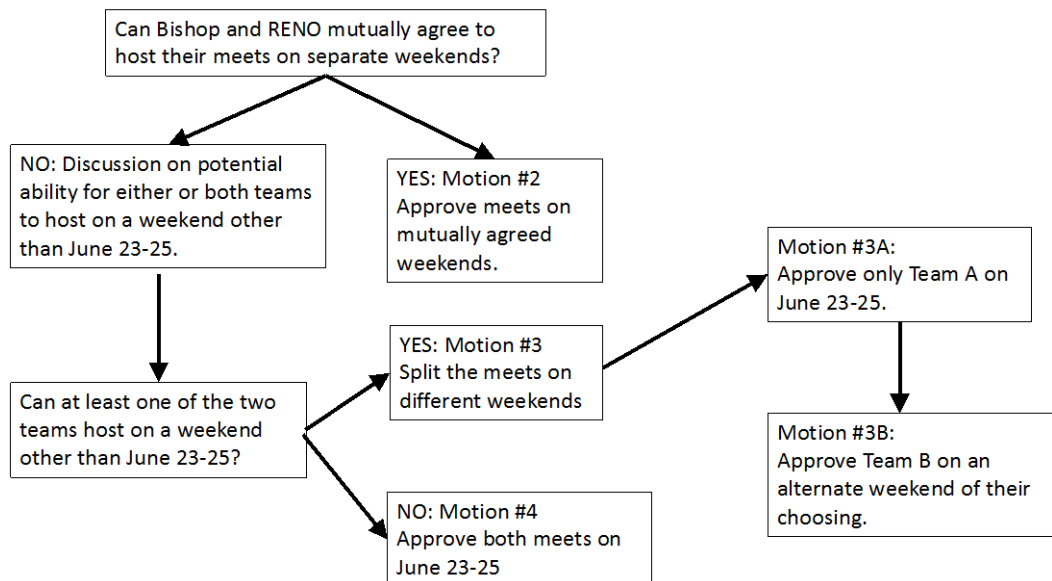
#### 4. New Business:

- Motion #1 (Hardt/Morefield): *The Zone-4 Board hereby approves any of the following alternate weekends for each of the June 2023 meets to be hosted by BST or RENO: June 9-11, June 16-18, June 23-25, June 30-July 2, 2023. Discussion and Action Item.*
  - Seconded. No discussion.
  - Passed unanimously.
- Proposed Decision Tree (Hardt): See attachment. **Discussion and possible action.**
  - Introduction of thought process behind the decision tree based on logical outcomes of available weekends.
  - Can Bishop and Reno agree to host their meets on separate weekends?
- Alternate Motions 2, 3, 3A, 3B, or 4 (Hardt): See attachment. One alternative based on results of Decision Tree. **Discussion and Action Item.**
  - Motion #2: Can Bishop and Reno agree to host their meets on separate weekends?
    - Discussion about restrictions from teams to host on particular weekends
      - RENO Coach Luke cannot host on June 16-18 because it is graduation weekend for Washoe County, would be difficult because of stress on volunteers. In addition, the city would prefer we stay off of Juneteenth weekend, but did not go so far as to say we could not have the pool. We cannot host June 9-11 as our kids are still in school

- and doing finals until the 13th. June 30-July 2 would be hard because of the 4<sup>th</sup> of July, and that weekend also is only 1 week out from JO championships and removes the ability to qualify for JOs. RENO has committed to sending swimmers to the Bishop meet if Bishop hosts on a different weekend.
- b. BST Coach Brittany can't have the pool Juneteenth weekend because of the State Rodeo (hotels are impossible), graduation weekend (June 9-11) is also similarly difficult. June 30<sup>th</sup> – July 2<sup>nd</sup> is also difficult for their teams and families because of difficulty of families volunteering and in visiting teams traveling due to the 4<sup>th</sup> of July holiday. If BST can't host on the 23-25, then they will likely cancel their meet or host an unsanctioned meet. 250 swimmers are needed to break even for the meet to be viable.
  - c. LAKE Coach Sharon mentions that in our bylaws, it is our purpose to support each team and swimmers. She sees the holiday weekend not being a downside for swim meets. There are plenty of teams who host meets on holiday weekends, including Carson Tigersharks. As far as qualifiers for JOs, there are other meets in other places, and also if Bishop were the weekend before, that would be a qualifier as well.
  - d. NNA question about graduation weekend for BST if it was Friday or Saturday. Answer was Friday night, but Brittany said that graduation weekend would really hinder their ability because they are such a small team. 5-6 families missing is a huge downfall for Bishop, whereas 5-6 families for RENO would not be.
  - e. Jim Morefield asked the group whether there would be a way for other teams to help out with volunteer jobs and with pooling resources on coaching to make sure that Bishop's meet could be held. Perhaps Zone 4 could subsidize Bishop if they don't break even based on both meets being on the same weekend (LAKE Sharon disagrees).
  - f. ROUNDTABLE on whether teams could support both meets on the same weekend.
    - i. DDST – Seems more likely that Reno could weather hosting on the later weekend better than Bishop could. If on the same weekend, DDST would be more than willing to help out with volunteer duties, etc.
    - ii. NNA – They would try to send athletes to both meets, but doesn't see how feasible it would be for coaching staff and for parents to agree to travel when they have a meet at home on the same weekend. They want swimmers to have the most opportunities for the most meets. Separate weekends would be advantageous.
    - iii. CARS – They wouldn't be able to support both meets if they were on the same weekend. They are not convinced that RENO couldn't host a meet if it was on the 30<sup>th</sup>. Bishop is so small that a different meet would cause their meet to fail.
    - iv. MLST – if both meets were on the same weekend, they would support Bishop. However, that would take the RENO meet off their calendar and reduces their ability to compete for the summer.
    - v. Jerry and Valerie – They like supporting the Bishop meet. If there was a commitment from teams to send the novice swimmers to Bishop and the experienced swimmers to RENO, that might work. Volunteer jobs, coaches, officials, etc, can be figured out probably.
    - vi. DISCUSSION about what happens if the motion to have meets on the same weekend fails. Answer was the teams host the weekend that they want. Devils advocate: the opposite, what if meets split passes and teams don't want to do it. If they apply for a sanction they won't get it.
    - vii. Unresolved – teams get back to Zone 4 about their weekend to host. Result means that both teams get to choose the weekend they want and Zone 4 will provide a sanction.
