All expenses are covered for coaches and chaperones. Applications may be handed in and questions answered at the NNA meet March 15-16. The team travels and competes in Sunnyvale, California, May 17-18.
  - b. **Reminder to High School athletes and their coaches:** carefully check the spelling of athlete names at high school meets **throughout the season**, and make sure errors get corrected ASAP. A typo, or a nickname, that does not match the athlete's USA Swimming registration may prevent or delay recording of times for USA Swimming at the high school championship meets in May. **This is the athlete's responsibility!**

# 6. Financial Report:

- a. Current balances (\$28,864.75) and recent activity
- b. PC Motion Approved: Host clubs of Zone meets to impose a facility fee not to exceed \$20.00 per athlete. Outreach registered athletes are exempt from the facility surcharge. Outreach athletes are identified by Pacific Swimming/LSC for meet hosts. This additional fee is optional and in addition to Splash Fee.
- c. PC Motion Approved: Increase of one dollar for a Premium Athlete Membership, from \$19 to \$20, and an Individual Season Athlete Membership from \$16 to \$17, effective September 1, 2025. USA Swimming no longer allows LSC's to charge a transfer fee.

- a. Athlete hyper-extended arm in gutter on backstroke finish at meet
- b. Other safety incidents or issues? A swimmer collision resulting in concussion at Blizzard Blast (Saturday). All swimmers and coaches are reminded that during meet warm-ups, it's always safest to complete the 25 instead of cutting into a return lane mid-pool where swimmers might collide.

### 8. Safe Sport:

- a. LSC Safe Sport Committee report (rep. Veronica Harmon) Reminder that MAAPP was updated in October and that all families need to sign annually. See upcoming Zoom Trainings for Parents & Swimmers. (Trainings: Parents--3/12, 4/2, 5/7 and 6/11 at 8:00 pm EST Athletes: 3/13, 4/3, 5/8 and 6/12 at 8:00 pm EST)

- b. All teams are asked to retain record of annual MAAPP signatures from swimming families.
- c. Currently Pacific Swimming has 22.7% clubs Safe Sport Recognized and all are encouraged to complete the process.
- d. Questions raised about why the annual acknowledgement of MAAPP isn't part of the USA Swimming Athlete Registration process. This might be an issue for teams registering their whole team, but including MAAPP Acknowledgement through USA Swimming regardless of registration method could be more efficient.

#### 9. Other LSC Reports:

- a. **Board of Directors** (reps. Jim Morefield, Erik Scalise, Bella Pflieger, Gracie Goss) -- Last BOD meeting 2/19, last Executive Committee meeting 1/15. Approved minimum age and other requirements for Athlete Reps. Approved 2025-26 LSC meet schedule. Approved up to \$20 per athlete facility surcharge for all meets, on a trial basis through August. Approved auditor report for previous fiscal year after presentation. Minutes available on the Pacific Swimming website. Next Exec meeting 3/19, next BOD meeting 4/16.
- b. **Disability, Diversity, Equity, & Inclusion Committee** (rep. Valerie Rudd) Issue surrounding groups that do and do not support DEI; work to organize tech suit exchange program; discussion about educating coaches about diversity & working with swimmers from diverse backgrounds.
- c. **Athlete Committee** (reps. Bella Pflieger, Gracie Goss, Millie Grieve, Pulin Muangsiri, Hadley Peck, MacKenzie Pierce, Kalia Ream) Bella shared that athlete committee is setting up a new leadership summit in October; also discussion about how best to define 'need' when it comes to the tech suit exchange program.
